Local Law No. 1 of the year 19 96

A local law in relation to electing a retirement incentive program pursuant to Chapter 30 (Insert Title) of the laws of 1996.

Be it enacted by the LEGISLATURE of the

Section 1. The county of Erie hereby elects to provide the benefits of chapter 30 of the laws of 1996 to its eligible employees pursuant to chapter 30 of the laws of 1996.

Section 2. The commencement date of the retirement incentive program shall be the fifteenth day of July 1996.

Section 3. The open period during which eligible employees may retire and receive the additional retirement benefit shall be 62 days, to commence on and include the fifteenth day of July 1996, and to end on and include the fourteenth day of September 1996.

Section 4. In interpreting this local law, the calendar dates set forth above as the opening and closing days of the open period shall be deemed controlling in determining the length of such open period, it being the intent of the legislature that the last date on which eligible employees shall work shall be no later than the thirteenth day of September 1996.

Section 5. The county of Erie will fund the retirement incentive program provided in chapter 30 of the laws of 1996 by paying the New York state and local employees' retirement system five annual payments, the amount of which shall be determined by the actuary. The first said payment is due the fifteenth day of December 1997.

Section 6. This local law shall take effect immediately.




