Section 1. Section one of Erie county local law number three of nineteen hundred ninety-seven is amended to read as follows:

§1. Pursuant to paragraph (d) (ii) of subdivision two of section four hundred fifty-eight-a of the real property tax law, as amended by chapter four hundred seventy-seven of the laws of nineteen hundred ninety-six, the maximum exemption from taxation of qualified real property under real property tax exemption allowable to qualified veterans in Erie county under paragraphs (a), (b) and (c) of subdivision two of section four hundred fifty-eight-a of the real property tax law shall be: with respect to paragraph (a) of said subdivision, eighteen thousand dollars; with respect to paragraph (b) of said subdivision, twelve thousand dollars; and with respect to paragraph (c) of said subdivision, sixty thousand dollars.

§2. This local law shall take effect immediately.




