MINUTES PUBLIC HEARING ERIE COUNTY SEWER DISTRICT NO. 5 INCREASE & IMPROVEMENT OF FACILITIES APRIL 10, 1997

PRESENT: Ms. Jackie Rushton, Legislature Office; Messrs. Alessi, Mallory and Ms. Susan Senker of the Erie County Department of Environment and Planning

Ms. Rushton called the April 10th public hearing to order at 1:30 p.m.

She proceeded to read the Legal Notice of the Public Hearing as published in the local and official County newspapers. Ms. Rushton then opened the public hearing and asked if anyone was present to speak in favor of the project.

Mr. Alessi spoke stating he was present as a representative of the Department of Environment and Planning, Erie County Sewer District No. 5 and the Erie County Sewer Agency.

Mr. Alessi said Erie County Sewer District No. 5 is looking for ways to reduce long term costs. The Town of Amherst receives and treats most of the flow from Erie County Sewer District No. 5. A change in the routing can be accomplished while reducing Erie County Sewer District No.5's operating costs. The sewage flow to the Swormsville Station can be redirected to the Amherst sewer system by crossing Transit Road. This would eliminate the station.

By the elimination of the two existing pumping stations that service Bridlewood and Hidden Oaks and designing a new gravity sewer for Stahley Road, a costs savings for \$50,000 per year in operating costs could be seen. By diverting sewer flows from Main and Transit, Eastern Hill Pump Station and Klein Road a better utilization of the existing capacity can be realized by Erie County Sewer District No. 5 and the Town of Amherst.

The total cost of the improvements is estimated at about \$2.8 million. \$2.1 million is for the installation of the gravity sewers on Bridlewood and Hidden Oaks Drive; \$247,000 for the elimination of the Swormsville pumping station and \$300,000 for the three road crossings. The operation and maintenance costs associated with the project results in a net savings of \$69,411 due to the elimination of three pumping stations. With the elimination of the three pumping stations it will also save the District \$1.5 million in future capital costs. There are no construction grants available to assist in the construction of the project. However, low interest loans are available through the New York State Revolving Loan Program.

There will be no connection costs associated with the project because the project will be serving existing sewered properties.

The Erie County Sewer District No. 5 Board of Mangers has approved this increase and improvement of facilities at their previous meeting.

The recommendation of the Erie County Sewer Agency Report are that the Legislature:

- 1. Accept and adopt the Sewer Agency Report;
- 2. Call and Hold a Public Hearing;
- 3. Approve the project and authorize an application to the NYS Department of Audit and Control; and
- 4. An approval by Audit and Control, approve a \$2.8 million bond authorization.

Ms. Rushton then asked if anyone else wished to speak at the hearing. There being none, the public hearing was closed at 1:40 p.m.
