WHEREAS, a major factor for high electric rates in New York is the rates charged to electric utilities by qualified small power producers, and

WHEREAS, the Public Utility Regulatory Policies Act of 1978 (PURPA) was enacted to ensure consumers would not have to pay higher mandated utility costs, and

WHEREAS, PURPA, however, has had an opposite effect on the cost of power to the electric utilities, therefore, increasing the cost of electricity to consumers, and

WHEREAS, these increased costs have been a major obstacle in New York's efforts in maintaining existing businesses, as well as competing with other states for new businesses, and

WHEREAS, H.R.4183, the State Electric and Consumer Empowerment Act of 1998, was introduced to protect the Nation's electricity ratepayers, and

WHEREAS, this bill provides the States the necessary authority to ensure that rates charged by qualified small power producers to electric utilities are just and reasonable, and

WHEREAS, H.R. 4183 also establishes effective programs for monitoring the operating and efficiency performance of qualified small power production facilities to maintain the standards of the Federal Energy Regulatory Commission.

# NOW, THEREFORE, BE IT

**RESOLVED,** that the Erie County Legislature does hereby support H.R. 4183, the State Electric and Consumer Empowerment Act of 1998, and be it further

**RESOLVED**, that H.R. 4183 this bill represents a vital step in reducing electric rates in New York which will help the State of New York more effectively compete for business, and be it further

**RESOLVED,** that this Honorable Body urges the Congress to pass and the President to sign into law H.R. 4183.

RESOLVED, That this Honorable Body does therefore memorialize the United States Congress to pass H.R.4183, H.R.4511, and S.2419 to accomplish the aforementioned goals, and be it further

RESOLVED, That this Honorable Body does also memorialize the United States Congress to appoint conference committees to resolve differences among these bills, and be it further

RESOLVED, That certified copies of this resolution be forwarded to the local delegation of the United States Congress and to President Bill Clinton.

RESOLUTION NO. 284 Re: Dedicating Proceeds from New York State Lawsuit on Tobacco Industry Toward Property Tax Reduction (Intro 17-8).

WHEREAS, In 1997, Eric County filed a \$500 million lawsuit against the tobacco industry seeking to recover damages from smoking-related illnesses and deaths, and

WHEREAS, New York State Attorney General Dennis Vacco has also initiated a lawsuit against the tobacco industry to recover damages from smoking-related illnesses, and

WHEREAS, expenditures by state and local (county) governments to address illnesses and deaths associated with tobacco products are estimated to be in the hundreds of millions of dollars, and

WHEREAS, expenditures for tobacco-related illnesses have primarily been made through Medicaid, a government health insurance program that is financed by state and local governments in various percentages, depending on the specific program or service, and

WHEREAS, Attorney General Dennis Vacco has stated that Erie County will share in any tobacco settlement proceeds "by virtue...of state and federal law", and

WHEREAS, under the Social Security Act, any recovery for Medicaid overpayments must be divided proportionately between the state and local governments, and

WHEREAS, Erie County could reap a huge financial windfall from the settlement of the legal action against the tobacco industry; for example, had the proposed \$368 billion tobacco settlement not failed in Congress, Erie County could have realized an estimated \$13 million for 25 years or approximately \$325 million, and

WHEREAS, depending upon the terms of the settlement, funds realized from the state's lawsuit against the tobacco industry could be used for any purpose, including property tax reduction, and

WHEREAS, property taxes in Erie County have risen by more than 70 percent since 1988, making the county one of the highest taxed communities in the country

#### NOW, THEREFORE, BE IT

**RESOLVED**, that the Erie County Legislature reiterates its support for the lawsuit filed by State Attorney General Dennis Vacco against the tobacco industry, and be it further

**RESOLVED**, that the Erie County Legislature is also reassured by comments made by Attorney General Vacco that the Social Security Act will guarantee a proportionate disbursement of any settlement award to the state and local government in a manner consistent with Medicaid expenditures, and be it further

**RESOLVED**, that should a settlement finally be reached and a monetary award be made to New York State, without specific mandates as to its use, the Erie County Legislature does hereby state its support for the use of the full amount of any settlement for property tax reduction, and be it further

**RESOLVED**, that a certified copy of this resolution be forwarded to County Executive Dennis Gorski, Comptroller Nancy Naples and Budget Director Kenneth Kruly.

RESOLUTION NO. 285 Re: Preserving Health Care Choice and Fleximility for WNY Senior Citizens (Intro 17-9)

WHEREAS, Erie County currently has 3,949 active employees enrolled with Independent Health, representing approximately \$14 million in premiums payments annually, and

WHEREAS, Erie County provides its employees with choice and flexibility in selecting from a variety of health care options for individuals and their families, and

WHEREAS, Despite the fact that local HMOs marketed their plans on the pretence of greater choice and flexibility, Independent Health recently announced plans to restrict the provider network for Medicare enrollees 65 and older, within its program known as Encompass 65, and

WHEREAS, Independent Health has approximately 25,000 members in its Encompass 65 program and approximately 50% of them currently obtain health care from hospitals that will be excluded from the HMO, and

WHEREAS, The Independent Health deal is the first exclusive arrangement between an HMO and one of the Western New York's new hospital systems, and

WHEREAS, CFG was formed earlier this year by the mergers of Buffalo General Hospital, Millard Fillmore Hospital, Children's Hospital of Buffalo and DeGraff Memorial Hospital, and

WHEREAS, The Independent Health exclusivity policy will exact a financial challenge on the five hospitals that joined ranks to establish the Catholic Health System, including Kenmore Mercy, South Buffalo Mercy, Our Lady of Victory, St. Joseph's and Sisters, and

WHEREAS, The restricted provider network for Medicare eligible residents will result in fewer health care choices and less flexibility, and

WHEREAS, The restricted provider network will also likely result in hospital closings and significant job losses in the health care industry,

WHEREAS, this action may also result in drastic financial hardship for other hospitals in the region, leading to widespread job layoffs and a generally less comprehensive level of medical service for residents in many areas of Erie County, and

WHEREAS, it is incumbent upon members of this legislature to examine the impact of any policy change the likes of which is planned by Independent Health, through committee meetings, public hearings and other means by which members may learn more about the potential impact of this decision,

NOW, THEREFORE, BE IT

RESOLVED, That the Erie County Legislature does hereby express its deep concern that the Independent Health exclusivity policies will severely restrict patient choice and flexibility, thereby compromising health care quality in Western New York, and be it further

RESOLVED, That the aforementioned exclusivity policies may also result in hospital closings and significant job losses in the health care industry, and be it further

RESOLVED, That this Honorable Body does reaffirm its support for a Western New York health care system that preserves choice and flexibility for residents without sacrificing quality of care, and be it further

RESOLVED, That officials from Independent Health are hereby requested to appear before the Legislature's Health Committee to address the aforementioned issues,

including their plans to exclude the Catholic Health System (CHS) from their provider network for Encompass 65 patients, and be it further

RESOLVED, that ECMC officials are hereby requested to provide an assessment of the short and long-term revenue impact of the Independent Health decision on the Medical Center's financial bottom line, and be it further

RESOLVED, that the Chairman of the Erie County Legislature is hereby authorized to schedule Public Meetings throughout local communities to discuss the impact of Independent Health's plans to alter the Encompass 65 program and services, with the first three Public Meetings scheduled as follows:

Philip Randolph Educational Fund (A-PREF),1444 I Street,NW Suite #300 Washington D.C. 20005, one of the most widely used respected foundations and government support job training initiatives, is designed to affect the economic fortunes of women minority and economically disadvantaged populations in America. Over its years of operation, R-T-P, Inc. helped more than 40,000 women minorities, and economically disadvantaged individuals in obtaining the necessary skills to enter permanent positions in the work force.

Whereas, The overall goal of this proposal is to provide recruitment, orientation, counseling, tutorial help, motivational training, job development, job referral, follow-up, and job retention for the Erie County Department of Social Services. The primary focus of this project is to assist the County of Erie to meet the work requirement set forth in under the Welfare Reform Act of 1996.

Whereas, Under the terms of this proposal R-T-P, Inc. establish an office of operation located in the City of Buffalo where there exist a heavy concentration of TANF recipients who are in need of assistance in gaining and retaining employment. This proposal calls for the placement of 96 recipients in gainful employment pre apprentice or apprentice training programs during the first year.

Whereas, R-T-P will identify a staff of local residents who will be trained and managed by a team of professionals who have extensive experience in this industry. As demonstrated by our established retention rate of more than 92%, the R-T-P model is an effective tool and will be employed in this project and
