WHEREAS, Following a petition drive and other community protests the New York
State Attorney General's Office conducted an investigation alleging that several companies and
Wegman's supermarkets conspired to do away with money-saving coupons, and

WHEREAS, The Attorney General reached an overall settlement of \$4.2 million involving 10 major grocery manufacturers — the largest-ever cash payout to New York State consumers, and

WHEREAS, In May and September of 1998 the state distributed the first two installments of the settlement to Buffalo, Rochester and Syracuse consumers in the form of \$2.50 and \$2 coupons, respectively, and

WHEREAS, According to the State Attorney General's Office there is still approximately \$1 million of the settlement yet to be distributed, and

WHEREAS, Former State Attorney General Dennis Vacco announced plans to deliver a third coupon to consumers in early 1999, and

WHEREAS, Current State Attorney General Eliot Spitzer has not yet formally announced plans for distribution of the remaining money, although informally it has been said that in compliance with terms of the settlement a third coupon would be distributed in late spring or early summer of 1999, with the remaining money then going to local food banks,

Re: Support of State Legis. To Amend County's Portion of Real Estate Transfer Tax. (Int. 7-13)

WHEREAS, The Niagara Frontier Builder's Association and the Greater Buffalo Association of realtors have adopted a resolution requesting that Erie County seek state legislative authorization to address the issue of "double taxation" as it relates to the county's portion of the real estate transfer tax, and

WHEREAS, The "double taxation" occurs when a home builder purchases a parcel of land for new housing construction and the same parcel of land is subsequently assessed another transfer tax when the property is improved and transferred to a new owner, and

WHEREAS, The costs associated with the aforementioned "double taxation" are virtually always passed along to new home buyers, thereby unnecessarily increasing the cost of home buying, and

WHEREAS, Subsequent to receiving State legislative authorization, Erie County's portion of the real estate transfer tax was enacted pursuant to Erie County Local Law #5 on April 6, 1990, and

WHEREAS, Based on figures provided by the Niagara Frontier Home Builder's Association and the Greater Buffalo Association of Realtors, the "double taxation" issue represents approximately \$150,000 each fiscal year

NOW, THEREFORE, BE IT
