WHEREAS, the Geneva B. Scruggs Community Health Care Center, Inc. and the County of Erie (hereinafter the "County") entered into a lease for the premises at the Geneva B. Scruggs Clinic in Old School 84 (567 Kensington) on the grounds of the Erie County Medical Center in the City of Buffalo, County of Erie, New York which lease expired as of March 31, 1995, leaving GBS as a holdover tenant to the current time; and

WHEREAS, by the lease terms, GBS was to pay rent of \$1 per year plus pay all utilities; and

WHEREAS, GBS has not paid the utilities for several years, and thus currently owes the County \$377,934 for back utility payments on the School 84 premises; and

WHEREAS, in addition, GBS has not paid the utility bills for the Intermediate Care Facility (hereinafter the "ICF"), and thus owes the County \$159,809 for back utility payments on the ICF premises; and

WHEREAS, GBS was given notice on or about April 29, 1998 to vacate the premises no later than July 1, 1998; and

WHEREAS, during negotiations between the parties, possession by GBS continued after the July 1, 1998 deadline, but the County can no longer extend such possession; and

WHEREAS, GBS was again given notice on or about March 4,1999 to vacate the premises no later than June 1, 1999; and

WHEREAS, commencing June 1, 1999, the County will be landlord to Community Health Care of Buffalo, Inc. (hereinafter "CHC") for the premises in the Old School 84 now occupied by GBS; and

WHEREAS, GBS has requested additional time in order to make a complete and smooth transition into new premises elsewhere; and

WHEREAS, in order to forego any lawsuit between the parties;

NOW, THEREFORE, BE IT

RESOLVED, the Erie County Legislature hereby authorizes and directs the County Attorney to enter into an agreement with the Geneva B. Scruggs Community Health Care Center, Inc. ("GBS") whereby GBS and the County of Erie stipulate and agree:

- 1. By December 31, 2000, GBS shall pay the County \$159,809 in full settlement of the outstanding utility payments it owes the County for the ICF premises, and such payment shall be made in equal monthly installments.
- 2. As of May 1, 1999, GBS shall remain current on all prospective utility bills for ICF.
- 3. GBS may remain on the premises until July 1, 1999 and shall vacate those parts of the premises as necessary for the renovations commencing June 1, 1999 by the County and for commencement of services there as of June 21, 1999 by Community Health Care of Buffalo, Inc. ("CHC").
- 4. As of June 1, 1999, GBS shall no longer provide clinical care at the Geneva B. Scruggs Clinic in Old School 84, but will continue to provide non-clinical services at that site until July 1, 1999.
- 5. In consideration of the above, the County of Erie, together with ECMC agrees:
 - (a) The County waives \$377,934 due in back utility payments for the premises at Old School 84.
 - (b) GBS may remain on the premises for the provision of non-clinical services during GBS's transition to their new facility until July 1, 1999 subject to the conditions outlined above.
- 6. Any breach of this agreement by GBS will result in the full \$377,934 becoming immediately due and payable to the County, and a reconsideration by the County of all other agreements and arrangements with GBS. The County reserves all its rights to any and all legal remedies, and it will proceed with eviction of GBS from the premises at Old School 84; and be it further

. ,

RESOLVED, the Erie County Legislature hereby waives the obligation by Geneva B. Scruggs Community Health Care Center, Inc. to pay \$377,934 due to the County for back utility payments owing from GBS' occupancy of the Old School 84 premises under the lease, provided that the terms and conditions of the above referenced agreement are fulfilled and not breached by GBS; and be it further

RESOLVED, that certified copies of this resolution be provided to the County Attorney, the Chief Operating Officer of ECMC, the County Budget Director, the County Executive and the County Comptroller.
