MEMORANDUM

SUMMARY

The attached resolution and accompanying memorandum request authorization to accept an award of \$45,807 from the New York State Archives, a division of the New York State Education Department, to enhance the permanent storage of Probationer Master Records.

FISCAL IMPLICATIONS

Per the award letter, 50% of the award will be forthcoming at the start of the project, 40% will be available as the project is completed and is requested for reimbursement, the last 10% will be available after the project is completed and all required forms are submitted. There is no match required.

REASONS FOR RECOMMENDATION

The Erie County Probation Department has received a letter of approval for funding from the New York State Archives, manager of the Local Government Record Management Improvement Fund (LGRMIF) for this purpose.

BACKGROUND INFORMATION

Last fall the Erie County Probation Department applied for a document conversion and access grant to digitize Probationer Master Records and establish an efficient way to retrieve them. The Department was informed November 23, 2011 that funding has been approved. The project must be completed by June 30, 2012 per the award letter.

The proposed project will allow the department to purchase scanner equipment, software, and imaging services. These investments will be used to modernize the record storage for those records which have permanent retention requirements and are currently in paper form. Transferring these documents into digital images will preserve the files longer than paper, and allow for faster less labor intensive retrieval. The digitized records will also require less physical space than their paper counterparts.

CONSEQUENCES OF NEGATIVE ACTION

The County will forfeit the funding.

STEPS FOLLOWING APPROVAL

Certified copies of this resolution will be forwarded to the Division of Budget & Management, the Office of the Comptroller, Personnel, and the Erie County Probation Office.
