ACCOMPANYING MEMORANDUM

Variable Minimum Authorization

I. Summary of Recommended Action

The proposed resolution and accompanying memorandum request authorization to refill a vacant position of Assistant District Attorney at a variable minimum step 5. This salary level will allow for hiring of an experienced lawyer.

II. Fiscal Implications of Proposal

The Erie County District Attorney's variable minimum salary step 5 authorization will incur no additional personal services costs. The newly vacated position was appropriated in 2012 at a step 5 with a longevity step due July 1, 2012. Hiring an experienced prosecutor at a variable step 5, will actually generate a savings of approximately \$966 as they would not be receiving that longevity step.

III. Reasons for Recommendation and Background of Proposal


In keeping with our practice of hiring the best and brightest to fill the most challenging positions within this office, it is important that these individuals are compensated appropriately. The Erie County District Attorney is prepared to fill an Assistant District Attorney IV position and would like to fill the vacancy at a variable minimum step 5. It is necessary to recruit at a higher pay level in order to gain well experienced prosecutors to serve the citizens of Erie County. As mentioned above, the funds necessary to recruit at this higher level have already been appropriated in the position's salary line.

IV. Consequences of Negative Action

Failure to approve this request could result in the loss of highly qualified and extremely knowledgeable individual who has tremendous appellate work experience and excellent credentials and would be impossible to find at a lower rate of pay.

V. Steps Following Approval of Measure

The District Attorney's Office will work with Personnel and the Division of Budget and Management to implement this proposal.

WHEREAS, in order for the Erie County District Attorney to continue his practice of hiring the best and brightest to fill the most challenging positions within his office, it is important that they are compensated appropriately; and

WHEREAS, all requests for authority to recruit at a higher increment level must be approved by both the Legislature and the Erie County Executive; and

WHEREAS, the Administration has experienced tremendous difficulty recruiting qualified candidates to as the starting salaries are not competitive with what private sector employers are paying; and

WHEREAS, the Erie County District Attorney is prepared to fill an Assistant District Attorney IV position at a variable minimum step 5 pending action from your honorable body; and

WHEREAS, the Erie County District Attorney's salary authorization will have no additional personal services costs, and will be implemented while keeping within the District Attorney's adopted appropriation for 2012; and

NOW, THEREFORE, BE IT

RESOLVED, that effective January 30, 2012, that the Erie County Legislature does hereby authorize a variable minimum step 5 for the position of Assistant District Attorney IV (position #51003273), in fund center 11400, for the year 2012, in accordance with the 2012 Adopted Erie County Budget and Erie County Personnel Policy, and be it further

RESOLVED, that the Director of Budget and the Commissioner of Personnel make any changes necessary to effectuate the implementation of this resolution, and be it further

RESOLVED, certified copies of this resolution be forwarded to the Erie County District Attorney, the Erie County Executive, the Commissioner of Personnel and the Director of Budget and Management.
