WHEREAS, Highway Law § 10(25) provides that the Commissioner of Transportation shall have power to combine, connect, alter, relocate, terminate, and pave intersecting highways, roads or streets and to provide drainage therefore; and to provide, when she deems it to be in the interest of public safety, for a suitable structure or structures across highways to accommodate at an adjusted grade the continuity of such highways, roads or streets by an under-pass or overpass, and to adjust grades and traffic to such structures; and any such portion of intersecting highway, road or street upon which such work is completed shall, if not determined by the Commissioner of Transportation to be a part of the state highway system, be maintained by the municipality or the municipalities in which such frontage, marginal or service road or such portion of intersecting highway, road or street is located; and

WHEREAS, a portion of Kinsley Road in the Town of Elma having been reconstructed by the Department of Transportation for the purpose of connecting the existing portion of Kinsley Road with SH 9217, it is NOW THEREFORE, HEREBY

ORDERED: That pursuant to Highway Law § 10(25), the following described portion of Kinsley Road, including any and all bridges and culverts located thereon or immediately adjacent thereto reconstructed under Contract D254900, is in the judgment of the Commissioner of Transportation, not deemed to be a part of the state highway system and all maintenance obligations of the State therein are hereby transferred to the Town of Elma, as follows:

Beginning at Centerline Station 15+0± (Kinsley Road) of contract D254900, accepted March 1, 1995, thence running northerly and easterly to station 8 +27.22± for a total distance of approximately 677.22± linear feet or .128± miles.

The above mentioned Centerline Station, as shown on the accompanying map, is established for the reconstruction of Route 20 intersection with Route 187, State Highways 9269 and 9217, as shown on a map and plan on file in the office of the State Department of Transportation in Buffalo; and it is

FURTHER ORDERED: That certified copies hereof be mailed to the Clerk of the Town of Elma, the Superintendant of Highways for the Town of Elma, the Clerk of the County of Erie, the Commissioner of Public Works of the County of Erie, the Clerk of the Erie County Legislature, the Erie County Comptroller's Office and the Office of State Comptroller.
