

RESOLUTION 2012-252

Raising the Threshold for Property Tax Exemption for Persons with Disabilities and Limited Incomes

WHEREAS, The Exemption for Persons With Disabilities and Limited Incomes property exemption (Local Law No. 4-1998) was passed by the Town of Amherst in 1998; and

WHEREAS, the enabling legislation from New York State allows for a base range of income \$3,000.00 to \$29,000.00 and the Town of Amherst chose \$24,000.00 as the base rate with a current maximum of \$32,400.00 utilizing the sliding scale for percent of exemption; and

WHEREAS, it has been fourteen (14) years since this base rate was set and there has been no adjustment to the base rate of \$24,000.00

NOW THEREFORE BE IT RESOLVED, that the Amherst Town Board wishes to raise the base rate to the current maximum allowable which is \$29,000.00 and

BE IT FURTHER RESOLVED that the Town Assessor calculate a new table using \$29,000.00 (the value of "M" pursuant to Town Code §175-26) as the new base amount and that this shall be in effect for the filing of the 2013 property exemptions and be it further,

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to the Erie County Legislature encouraging the County of Erie to follow suit in raising their base income limit.
