I am pleased to be able to share with you this recent correspondence from Jeffrey Cannell, the Deputy Commissioner of Cultural Education and Acting State Librarian, regarding the Buffalo & Erie County Public Library System's efforts to become a special legislative district public library.

As you'll see from Mr. Cannell's letter, the Library System's Library District Initiative is aligned

1. "with the Board of Regents statewide policy for library services," and
2. "with other State government initiatives that encourages the voluntary consolidation of local governments in order to achieve both improved services for the public as well as future cost efficiencies and economies of scale."

It is my hope that you will review Mr. Cannell's letter with an open mind regarding our efforts. Becoming a library district will replace 23 separate boards of trustees with one elected board and will replace 23 separate hiring authorities with one. The Library's governance and hiring processes will be streamlined.

Just as important will be the Library's financial stability. By having the public vote on and approve the Library's budget through community based funding, the Library's financial future will be secured.

You have asked the New York State Library to confirm information about the current governance structures of the Buffalo & Erie County Public Library (BECPL) and its 22 independent member libraries. As described in more detail within this letter, the State Library confirms that BECPL and each of its member libraries are currently established as separate and independent legal corporate governmental entities.

The State Library is also pleased to confirm that BECPL's proposed plan for the creation of a new countywide special legislative district public library for Erie County is aligned with the Board of Regents statewide policy for library services. Regents policy supports the voluntary formation of public library districts statewide, except in New York City, which is served by consolidated library systems that provide library services for every resident. In addition, the BECPL proposed plan is also aligned with other State government initiatives that encourage the voluntary consolidation of local governments in order to achieve both improved services for the public as well as future cost efficiencies and economies of scale.

Governance Structure of the Buffalo & Erie County Public Library

The Buffalo & Erie County Public Library (BECPL) is currently a municipal public library established to serve the residents of Erie County. While the majority of BECPL's local public income is provided by Erie County, the library is legally established as a separate and independent education corporation and is not a department of the county and is not part of the county government.

As a municipal public library, BECPL is governed by a single Board of Trustees with 15 members. Of the 15 Board members, 10 are appointed by the County Executive and five are nominated by Buffalo's Mayor. All BECPL Trustee appointments are subject to the approval of the County Legislature.

In addition to operating the Central Library and the 8 branches located in the City of Buffalo, BECPL also manages the county funding that supports the staffing and operations of the 22 independent local public libraries in 28 locations that are located outside of the City of Buffalo. BECPL currently manages the county funding that supports the operations of all 37 library outlets located throughout Erie County.
