Re: Erie County's 1% Sales and Compensating Use Tax Revenue Sharing with Local Governments

Dear Sir or Madam:

I am writing to formally inform you of the remittance of \$12,500,000 of sales tax revenue to the cities, towns and villages pursuant to the Erie County Legislature's reauthorization of Erie County's ("County") one percent (1.00%) sales tax.

Pursuant to the 1% sales tax reauthorization, \$12,500,000 of the County's 1% sales tax is being shared with the local governments in 2012. Those funds are required to be shared with the cities, towns and villages pursuant to the 3% formula for those entities. Attached hereto is a report detailing the apportionment and distribution of the \$12,500,000. Payment to these municipalities has been made as of this date.
