# **SUMMARY**

This resolution is requesting authorization for the County Executive to enter into an Agreement Amendment with the architectural firm of Advanced Architecture and Planning for providing Architectural/Engineering Services to provide the design and construction documents for a roof replacement project located at Erie Community College – City Campus - 45 Oak Street.

# FISCAL IMPLICATIONS

Funds for the project are currently from the approved and adopted 2011 County Budget. The SAP project account is delineated as such:

E.11003 2011 Erie Community College- Roofs Collegewide (Countywide) \$25,000.00

## **REASON FOR RECOMMENDATION**

The roof system has exceeded its useful life and to avoid further costs associated with temporary "stop-gap" measures just to keep the building weather tight, a full roof replacement is warranted.

# **BACKGROUND INFORMATION**

Erie Community College – City Campus - at 45 Oak Street, is in need of a roof replacement in order to keep the facility in weather tight condition. The existing 30 plus year roof system requires continual maintenance to troubleshoot and stop roof leaks and if the roof is not replaced this condition will continue to cause further damage to the building interior space and systems.

# CONSEQUENCES OF NEGATIVE ACTION

If this project is not completed, the roof will continue to leak and will lead to further deterioration of the building and ultimately closure of the facility because it will become unsafe to occupy.

# **STEPS FOLLOWING APPROVAL**

The County Executive will enter into an Agreement Amendment with the architectural firm of Advanced Architecture and Planning for providing Architectural/Engineering Services to provide the design and construction documents for a roof replacement project located at Erie Community College -City Campus - 45 Oak Street.

WHEREAS, the Legislature has previously authorized the County Executive to enter into a General Architectural/Engineering Services Agreement with Advanced Architecture and Planning for providing professional design and construction document services on Erie County projects; and

WHEREAS, the County Executive is requesting authorization from the Legislature to issue an Agreement Amendment to Advanced Architecture and Planning for providing design and construction documents services for the roof replacement project at Erie Community College's City Campus, 45 Oak Street building; and

#### NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is authorized to issue an Agreement Amendment to Advanced Architecture and Planning for providing professional design and construction document services for the Erie Community College's City Campus, 45 Oak Street building for an amount not to exceed \$25,000.00; and be further

RESOLVED, that the Comptroller's Office be authorized to make payment for all the above from SAP project account E.11003- 2011 Erie Community College- Roofs Collegewide (Countywide) for an amount not to exceed \$25,000.00; and be it further

RESOLVED, that two certified copies of this resolution be sent to the Department of Public Works, Commissioner's Office, and one copy each to the Office of the County Executive, the Division of Budget and Management, and the Office of the Comptroller.
