As reported in Dave's email below, SHPO has approved an extension to the grant which will allow the county to move forward on the restoration of the foundations in houses 2 & 3. While this is great news, it is only for the foundation work. Half of the estimated cost is \$60,000 and the Gardens will pay the other \$60,000. We have essentially lost the remaining \$140,000 that was a modification to the grant to apply towards the overall restoration of houses 2 & 3.

Dave, thank you for your efforts in writing the letter for the extension and sending to Mr. Poloncarz for his signature, otherwise we would have lost the entire grant! Now, let's get those foundations restored.
