## **MEMORANDUM**

**To:** Honorable Members of the Erie County Legislature

**Re:** Amendatory Agreements to Two Affordable Housing Contracts, (1) New Opportunities Community Housing Development Corporation – Purchase, Rehab, Sale Program, and (2) The Service Collaborative of Western New York, Inc. – Housing Rehabilitation School Street Neighborhood, West Seneca

### **SUMMARY**

The resolution authorizes the County Executive to execute amendatory agreements to the following contracts.

1. October 21, 2011 agreement with New Opportunities Community Housing Development Corporation, increasing the authorized amount from \$225,467 to \$458,500.85
2. July 27, 2008 agreement with The Service Collaborative of Western New York, Inc. (FKA Western New York Americorps), increasing the authorized amount from \$108,950 to \$130,450.

### **FISCAL IMPLICATIONS**

There are no County funds involved, thus there is no fiscal impact to Erie County.

### **REASONS FOR RECOMMENDATION**

The federal Department of Housing and Urban Development (HUD) requires that at least 15% of all HOME grant funds allocated to the HOME Consortium be utilized by Community Housing Development Organizations (CHDO). These are non-profit agencies organized under state or local law, where their governing board and organizational structure reflect their accountability to low-income residents. New Opportunities and The Service Collaborative qualify as CHDOs.

The selection of New Opportunities and The Service Collaborative were subject to the consultant selection process as required under Section 19.08 of the Erie County Administrative Code. Results of the process are attached to the resolution. (See Attachment A)

### **BACKGROUND INFORMATION**

The amendments will allow the following to occur.

- New Opportunities will be able to purchase, rehabilitate and sell two (2) additional houses for eventual sale to an eligible low/moderate income applicant. The houses must be located within the Erie County HOME Consortium service area. (See Attachment B)

- The Service Collaborative will complete the rehabilitation of the two-unit residential structure at 20 School Street in the Town of West Seneca. It will then be rented to eligible low and moderate income households for the fifteen year affordability period.

### **CONSEQUENCES OF NEGATIVE ACTION**

Erie County would have to find other eligible projects within a very limited federal time frame.

### **STEPS FOLLOWING APPROVAL**

The County Executive will execute agreements with New Opportunities Community Housing Development Corporation and The Service Collaborative of Western New York, Inc. for those projects described in the above paragraphs.

WHEREAS, Community Housing Development Organizations (CHDO) are non-profit agencies established under federal or state law where their governance structure is inclusive of and responds to the needs of low-income households within a specific service area; and

WHEREAS, New Opportunities Community Housing Development Corporation is a qualified CHDO and executed a \$225,467 contract with Erie County on October 21, 2011 to undertake a purchase, rehab, and sale program within the Erie County HOME Consortium for low and moderate income households; and

WHEREAS, New Opportunities has requested an additional \$233,033.85 allowing the purchase of two more housing units for eventual improvement and sale as affordable housing; and

WHEREAS, The Service Collaborative of Western New York, Inc. (FKA Western New York Americorps) is a qualified CHDO and executed a \$95,000 contract with Erie County on July 27, 2008, and a \$13,950 amendment on June 17, 2010, to undertake the rehabilitation of a two-unit residential structure located at 20 School Street in the Town of West Seneca; and

WHEREAS, The Service Collaborative is seeking an additional \$21,500 to address foundation and lead paint issues within the structure; and

WHEREAS, the County of Erie has been awarded a federal HOME Investment Partnership grant of \$1,052,135 for fiscal year 2011 and \$694,898 for fiscal year 2012 by the United States Department of Housing and Urban Development; and

WHEREAS, a minimum of fifteen percent of said funds are to be provided to eligible Community Housing Development Organizations (CHDOs).

**NOW, THEREFORE, BE IT**

RESOLVED, that the Erie County Executive is hereby authorized to execute a First Amendatory Agreement to the October 21, 2011 contract with New Opportunities Community Housing Development Corporation for the Purchase, Rehab, and Sale Program increasing the contract amount from \$225,467 to \$458,500.85; and be it further

RESOLVED, that the Erie County Executive is hereby authorized to execute a Second Amendatory Agreement to the July 27, 2008 contract with The Service Collaborative of Western New York, Inc. for the rehabilitation of 20 School Street in the Town of West Seneca, increasing the contract amount from \$108,950 to \$139,450; and be it further

RESOLVED, that disbursement of said funds shall be conditioned on the following:

1. Completion of all state and federal environmental review requirements.
2. Completion of all necessary subsidy layering analyses as required by the federal Department of Housing and Urban Development.

And be it further

RESOLVED, that certified copies of this resolution be forwarded to the County Executive; the Commissioner of the Department of Environment and Planning; the County Comptroller; the County Attorney; and the Director of the Division of Budget and Management.

Three CHDOs responded to the CHDO Request for Proposals. Two of the three CHDOs projects are being recommended for funding at this time. Additional information is needed before the third project can be approved for funding.

In my opinion, it is recommended: New Opportunities Community Housing Development Corp. and The Service Collaborative of Western New York, Inc. be approved to develop affordable housing for low income households in the Erie County HOME Consortium communities. The Department of Environment and Planning (DEP) has complied with all applicable provisions of Section 19.08 of the Erie County Administrative Code.
