### **SUMMARY**

The Retired Senior Volunteer Program (RSVP) grant has been awarded \$15,000 for the promotion of a nationwide replication of the program's effective practices.

## FISCAL IMPLICATIONS

No additional County funds are required.

# **REASONS FOR RECOMMENDATION**

The \$15,000 award is a national award from National Association of Area Agencies on Aging (n4a) recognizing RSVP's University Express program as a best practice in volunteer recruitment and civic engagement. It provides replication funding to develop an online guide, webinar, and presentation at a national conference, as well as mentoring other organizations about how to start a similar lifelong learning program. The award was one of six given at the City/County level.

## **BACKGROUND INFORMATION**

University Express offers free academic classes at senior centers for adults age 55+. The classes are given by volunteer instructors drawn from retired and active faculty and other professionals. University Express is one of RSVP's most successful vehicles for volunteer recruitment. Since the program began in 2006, thousands of older adults have attended classes. University Express has significantly increased the capacity of RSVP to connect with potential volunteers, and the capacity of senior centers to visibly offer high quality lifelong learning opportunities, attracting new members, and expanding civic engagement in the senior center.

## CONSEQUENCES OF NEGATIVE ACTION

If this award is not approved, then RSVP will not have the benefit of an additional \$15,000 to strengthen the University Express, including marketing efforts to increase community awareness about University Express classes and RSVP volunteer opportunities.

# STEPS FOLLOWING APPROVAL

The Department will process the budget revisions and RSVP will prepare a webinar and guide to promote replication of RSVP's effective practices nationwide.
