1815 Eggert Road

WHEREAS the premises at 1815 Eggert Road in the Town of Amherst was previously used as a dry cleaning business and a gasoline station; and

WHEREAS such premises has been abandoned for many years and there is evidence that the site is a Brownfield Site needing remediation; and

WHEREAS no property taxes have been paid for the parcel since 2005, but Erie County does not want to offer it for sale at a tax foreclosure sale because it does not want to become liable for the cost of cleaning up the site; and

WHEREAS the New York State Environmental Conservation Law §56-0508 provides that a municipal body like the County of Erie with the authority to foreclose on tax liens can obtain temporary incidents of ownership so that the DEC can perform an environmental restoration investigation project upon the property without the County becoming liable for the clean-up cost which are added to the property taxes owed for the site; and

THEREFORE BE IT RESOLVED that the Amherst Town Board hereby requests that the County of Erie undertake the necessary steps required by Environmental Conservation Law §56-0508 to obtain temporary incidents of ownership so as to allow the New York Department of Environmental Conservation to do an environmental restoration project on the site and that the Erie County Legislature pass a resolution requesting such action by the appropriate Erie County officials.
