REASONS FOR RECOMMENDATION

BACKGROUND INFORMATION

On February 3, 2011, the Erie County Legislature passed a resolution (Comm. 17E-7) authorizing a 3-year Term Agreement with DiDonato Associates. At the time of the contract award, the Division of Sewerage Management committed to notifying the honorable legislature of each work order issued.

The Term Agreement was approved to provide the Division of Sewerage Management with engineering services required to complete various construction inspections throughout the Erie County Sewer Districts.
