Dear Mr. Graber:

Theatre of Youth Company, Inc. (TOY) received a \$6,000 grant from the County of Erie for our company to make improvements to our stage lighting as stated in Exhibit A of our contract.

The capital funds received were spent on a <u>Theatrical Lighting Truss</u>--a construction of tubular steel onto which lighting instruments are hung and which is in turn suspended above the stage. This truss has improved our stage lighting immensely as it provides a key position where lighting instruments can be more closely focused on performers.

The truss unit was ordered by TOY's production manager Chester Popiolkowski on December 14, 2011 and due to the fabrication and production schedule it was finally installed on February 14, 2012. The total cost for the Truss purchase from *Syracuse Scenery & Stage Lighting Co., Inc.* was \$5,790 (see attached invoice/check stub). Additional materials from *Production Advantage, Inc.* were required for the installation that valued \$589.94 (see attached receipt).

The total project expenditure was \$6,379.94. The vendors above were paid in full on March 1, 2012 and January 5, 2012, respectively. All of the funds received from the County of Erie were expensed.
