SUMMARY

Approve the attached resolution to revise the III-C1 2012 Congregate Dining grant budget, for the period January 1, 2012 to December 31, 2012, to allow for an increase in the total paid to the Salvation Army for meals it prepares and serves to seniors.

FISCAL IMPLICATIONS

No additional County funds are required.

REASONS FOR RECOMENDATION

The Salvation Army is projected to serve more meals to senior citizens in 2012 than initially budgeted for.

BACKGROUND INFORMATION

The Salvation Army, under contract with Senior Services, prepares and serves, at their Main Street location in Buffalo, a daily hot lunch for seniors. Senior Services reimburses the Salvation Army \$4.16 for each meal served.

CONSEQUENCES OF NEGATIVE ACTION

The Department would be unable to reimburse the Salvation Army for all congregate meals the agency will serve to seniors in 2012.

STEPS FOLLOWING APPROVAL

The Department will revise the III-C1 2012 Congregate Dining grant budget and Salvation Army contract.
