SUMMARY

Final acceptance of the GPI Agreement dated November 29, 2007 in the final amount of \$189,999.93 is requested.

FISCAL IMPLICATIONS

REASONS FOR RECOMMENDATION

The scope of services for each work order under this Engineering Agreement has been completed. It is the Division's recommendation to finalize this Contract.

BACKGROUND INFORMATION

On November 29, 2007 an Engineering Agreement was awarded by the Erie County Legislature to GPI. The consultant engineer was retained to complete various construction inspections as needed throughout Erie County Sewer Districts. The work has been satisfactorily completed.
