SUMMARY

Approve the attached resolution to authorize the County Executive to enter into a contract with the City of Lackawanna to join the Department of Senior Services Going Places Transportation for the Elderly Program.

FISCAL IMPLICATIONS

No county funding is required. Lackawanna will cover van operating costs.

REASONS FOR RECOMMENDATION

The City of Lackawanna desires, beginning in 2013, to provide senior transportation services as part of the Department's Going Places Transportation program. The Department has a van available for the City of Lackawanna's use to provide such senior transportation services.

BACKGROUND INFORMATION

Lackawanna currently does not participate in the Department's Going Places Transportation program.

CONSEQUENCES OF NEGATIVE ACTION

The Department will not be able to contract for the operation of vans and provide this service for the benefit of seniors in City of Lackawanna.

STEPS FOLLOWING APPROVAL

The Department will process the contract and take the steps necessary to continue the services.

RESOLVED, that the County Executive be and hereby is authorized to enter into a contract with City of Lackawanna for the operation of a Transportation for the Elderly Program van to provide senior transportation services under the Department's Senior Transportation program for the period January 1, 2013 to December 31, 2013; and be it further

RESOLVED, that certified copies of this resolution be forwarded to the County Executive's Office, the Division of Budget and Management, the Comptroller's Office, and the Departments of Law and Senior Services.
