SUMMARY

The Western New York Land Conservancy ("WNY Land Conservancy") recently obtained ownership of a parcel of land, known as the "Mossy Point Preserve" situate adjacent to the County's Sgt. Mark A. Rademacher Memorial Park, commonly referred to as Hunters Creek Park. The WNY Land Conservancy has requested permission to make trail connections between Hunters Creek Park and the Mossy Point Preserve.

FISCAL IMPLICATIONS

None.

REASONS FOR RECOMMENDATION

The Erie County Land Advisory Review Committee ("ARC") reviewed the request and has recommended that the request be granted so the WNY Land Conservancy can safely provide public access to the Mossy Point Preserve.

BACKGROUND INFORMATION

The Erie County Department of Parks, Recreation & Forestry is proposing to allow the WNY Land Conservancy to construct and maintain a small trail (approximately 50-75 yards long) on County property. This connecting trail would provide a link between trails at Hunters Creek Park and a new trail network to be constructed at the newly acquired Mossy Point Preserve. The connecting trail would allow users of the Hunters Creek trails to explore over 200 acres of newly acquired preserve via a new trail system to be constructed by the WNY Land Conservancy. The connection would likely spread out the use of trails throughout both properties; thereby reducing the wear and tear that currently only takes place on the Hunters Creek trails.

CONSEQUENCES OF NEGATIVE ACTION

Without approval of this connection plan, the wear and tear of the trail system at Hunters Creek Park will continue to be a concern. This project would likely reduce usage on the existing trails by allowing users to explore the previously inaccessible Mossy point Preserve.

STEPS FOLLOWING APPROVAL

Authorize the County Executive to enter into an agreement with the WNY Land Conservancy to construct new trail connections between Hunters Creek County Park and WNY Land Conservancy Mossy Point Preserve.
