RE: Authorization to accept funding and enter into contracts for New York State Public Health Corps Fellowship Program

Dear Honorable Members:

The Erie County Department of Health is eligible to receive a Public Health Corps Fellowship Program through Health Research Inc. (HRI/NYSDOH). A total of \$12,350,184 over the next two years (\$6,175,092.00 annually) is available for Erie County through a Center for Disease Control and Prevention (CDC) sponsored cooperative agreement for Epidemiology and Laboratory Capacity for infectious Disease (ELC).

The total funds of \$12,350,184 over a two-year period would allow up to 80 public health fellows annually, of which 11 would be graduate fellows. All of the positions will be maintained and employed by Coordinated Care Services Inc. CCSI provides a broad array of management services and technical assistance specifically tailored to meet the needs of local behavioral health, social and human services departments, state agencies, and community-across New York State and they are uniquely suited to manage this program.

SUMMARY

The purpose of this resolution is to authorize the Erie County Department of Health to accept funding from New York State Public Health Corps and to enter into a sole source agreement with CCSI for the hiring of public health fellows.

The funding will be used to recruit, train, deploy and manage the fellows serving our local health department. It will also help to improve our capacity in targeting specific communities in need within our county.

FISCAL IMPLICATIONS

Positive. This is 100% state share grant with no county matching dollars.

REASONS FOR RECOMMENDATION

The New York State public health corps was an idea launched in 2020 as a response to the COVID-19 pandemic. Conceptually the public health corps will train and organize a groups of public health experts who will serve as reserve of staff in the event of future pandemics or other public health crises. Over a two-year period, Erie County would be responsible for, and benefit from, the training of 80 total fellows, 11 of whom would be from local graduate school programs. The fellows would receive compensation and benefits as part of their training package.

By accepting this funding, the fellows hired by Coordinated Care Services would enhance the Erie County Department of Health's ability to respond to current and emerging public health emergencies. It would also allow the department to improve its health education services to inform and protect our community. By doing such we will be able to improve our outreach to our vulnerable populations and enhance the local COVID-19 public health response regarding testing, contact tracing, vaccination, prevention campaigns along with community education and operations. Through this partnership the fellows hired will be able to address the ongoing needs of our community over the next two years.

The Coordinator position hired by CCSI will work with the Erie County Department of Health to identify host organizations to provide work experience for fellows, which can include Federally Qualified Health Centers (FQHCs), NYS Designated Rural Health Centers, community-based organizations and other locations approved by New York State Department of Health (NYSDOH).

Coordinated Care Services Inc. (CCSI) would be the sole contractor in the hiring and onboarding of the fellows. CCSI has a long history of working with Erie County Department of Mental Health along with several other counties within New York State including Onondaga and Monroe Counties. Fringe and indirect costs will be paid for out of the funding received from New York State Public Health Corps. These costs include a 15% administrative fee and a 31% fringe benefit cost. Coordinated Care Services will also provide services for ongoing employment of staff that are needed. These needs will be determined by the Eire County Health Department and also by the various Community Organizations that wish to use fellows to assist with projects within their perspective organizations. These include background checks, benefits coordination and overall work performance issues in conjunction with input from the program coordinator. Coordinated Care Services will work closely with Eire County Department of Health (ECDOH) regarding work performance issues and placement concerns.

CONSEQUENCES OF NEGATIVE ACTION

Erie County would be unable to take advantage of this grant program.

STEPS FOLLOWING APPROVAL

The Erie County Department of Health will follow the appropriate steps necessary to accept the funding. A contract will be issued to Coordinated Care Services Inc. to begin the hiring and onboarding process.
