Summary of Recommended Action

The Legislature needs to approve the transfer of seized asset funds to Crime Stoppers WNY and to pay for the required FAA pilot certification and travel expenses.

Fiscal Implications of Proposal

This resolution will not have any impact on the 2021 County Budget.

Reasons for Recommendation

The area has seen an increase in gun-related violence over the past year, and Crime Stoppers WNY continues to encourage citizens to come forward with information about the violence with rewards.

The organization's "Help Stop the Violence" initiative is designed to increase crime-solving rates by encouraging community engagement. Crime Stoppers WNY regularly offers and pays rewards for information leading to the arrests of subjects involved in violent acts.

The Sheriff's Office has been a long supporter of Crime Stoppers and seeks to transfer \$10,000.00 to support Crime Stoppers WNY and its mission for safer streets.

The Erie County Sheriff's Office also seeks to pay for required pilot training. The agency has two licensed pilots for Air-1, and the pilots need to complete the required Federal Aviation Administration certification.

Under Federal Aviation Regulations (14 CFR §61.133), a commercial pilot rating is required for missions flown in support of law enforcement. Obtaining this certification and rating ensures proper rating for the Sheriff's pilots.

Additional Recurrency and Proficiency training is sought. During this pilot training course, the pilots perform emergency flight procedures in simulated scenarios. These training scenarios include full touch-down autorotation, simulated engine failure, hydraulic failure, and simulated tail rotor malfunctions.

The ECSO is requesting authorization to transfer \$127,000.00 from the seized asset account to support Crime Stopper WNY and pilot certification.

As of April 15, the balance of the account is \$536,660.00.

Consequences of Negative Action

Failure to approve this request will prevent the Sheriff's Office from utilizing seized assets to fulfill the FAA requirement and could keep Air-1 grounded in times of emergency. It would also halt needed funding for Crime Stopper WNY.

Steps Following Approval of Measure

Certified copies of this resolution shall be forwarded to the County Executive, County Comptroller, Division of Budget and Finance, Division of Purchasing, and the Sheriff's Office for implementation.

WHEREAS, the Sheriff's Office has two licensed that need to fulfill this FAA requirement; and

WHEREAS, the pilots also will complete Recurrency and Proficiency training; and

WHEREAS, this training complies with FAA Federal Aviation Regulation §61.56; and

WHEREAS, during this pilot training course, the pilots perform emergency flight procedures in simulated scenarios, which include full touch-down autorotation, simulated engine failure, hydraulic failure, and simulated tail rotor malfunctions; and

WHEREAS, the Sheriff's Office is utilizing seized assets to certify two Deputies to the FAA requirement and complete Recurrency and Proficiency, as well as for Crime Stoppers WNY; and

WHEREAS, the Asset Forfeiture Trust Account balance as of April 26, 2021, is \$536,660.00; and

WHEREAS, these initiatives will not have any fiscal impact on the 2021 County Budget; and

WHEREAS, the items requested meet the U.S Justice and Treasury department's guidelines outlined in the July 2018 Guide to Equitable Sharing. Each year, the Erie County Sheriff's Office recertifies with the departments to maintain its program eligibility.

NOW, THEREFORE, BE IT

RESOLVED, the Eric County Legislature authorizes the Eric County Sheriff's Office and Division of Budget and Management to transfer \$10,000.00 from the Asset Forfeiture Trust Account #421550 to account #516410; and be it further

RESOLVED, the Eric County Legislature authorizes the Eric County Sheriff's Office and Division of Budget and Management to transfer \$117,000.00 from the Asset Forfeiture Trust Account #421550 to account #510100 – Out of Area Travel:
