SUMMARY

On March 11, 2021 President Biden signed into law the American Rescue Plan (ARP). This legislation contains a wide array of stimulus and recovery funding designed to ensure the nation's swift economic and public health recovery from COVID-19. Your Honorable Body approved this spending plan in COMM. 13E-15.

Under the "RENEW Plan" the Department of Social Services was awarded \$125,000 to provide legal support for older adults, \$50,000 in interpreter and language access services, \$100,000 for technical upgrades to Resettlement agencies, and \$1,000,000 to provide grants to shelters to make necessary upgrades needed to recertify. It is recommended that the Erie County Legislature approve this resolution to enter into contracts with the following organizations—Center for Elder Law \$125,000 to provide legal support for older adults, International Institute \$50,000 to provide interpreter and language access services, Catholic Charities \$25,000, International Institute \$25,000, Jewish Family Services \$25,000 and Journey's End \$25,000 for technical upgrades. The Department of Social Services released a Request for Proposal (RFP) for organizations to provide the necessary repairs to homeless shelters in order to make them certifiable under the new regulations. Based on the response for this RFP we would like to contract with Saving Grace Ministries to complete repairs in the amount of \$261,500 to make their shelter certifiable.

FISCAL IMPLICATIONS

Funding for this project has been allotted within the Erie County 2022 Adopted Budget.

REASONS FOR RECOMMENDATION

The American Rescue Plan Omnibus Spending Package – the "RENEW Plan" provides a wide array of stimulus and recovery funding designed to ensure the nation's swift economic and public health recovery from COVID-19. These funds must be encumbered by December 31, 2024 or returned to the U.S. Treasury which would cause a loss of needed services throughout Erie County.

CONSEQUENCES OF NEGATIVE ACTION

Any ARP funds not encumbered by December 31, 2024 must be returned to the U.S. Treasury. Execution of these contracts will ensure that funding stays in Erie County.

STEPS FOLLOWING APPROVAL

The Department of Social Services will establish contracts with Catholic Charities, International Institute, Journey's End, Jewish Family Services, Center for Elder Law, and Saving Grace Ministries, Inc.

WHEREAS, the American Rescue Plan was signed into law on March 11, 2021; and

WHEREAS, the Erie County Division of Budget presented a plan which was approved by your honorable body with COMM. 13E-15 (2021); and

WHEREAS, funding for these services have been included in the 2022 Adopted budget; and

WHEREAS, the Department of Social Services was awarded funding under this plan in the amount of \$1,275,000 to provide needed services in the community; and

WHEREAS, the Department of Social Services issued a Request for Proposal (RFP) #2022-001VF to seek out Homeless Shelters needing Certification Support; and

WHEREAS, Erie County Department of Social Services desires to contract with Center for Elder Law \$125,000 to provide legal support for older adults, International Institute \$50,000 to provide interpreter and language access services, Catholic Charities \$25,000, International Institute \$25,000, Jewish Family Services \$25,000 and Journey's End \$25,000 for technical upgrades and Saving Grace Ministries to complete repairs in the amount of \$261,500 to make their shelter certifiable; and

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to enter into all contracts necessary to implement these projects relative to the American Rescue Plan – the "RENEW Plan"; and be if further

RESOLVED, that sufficient funding is available for this purpose in the 2022 Adopted Budget in Fund Center 110 and Accounts 516020, 516425, 516450, and 561410; and be it further

RESOLVED, that the Director of Budget and Management is hereby authorized to make any additional budget adjustment which may be required in order to match expense with Federal funding allocation adjustments, and be it further

RESOLVED, that certified copies of this resolution shall be forwarded to the Erie County Executive, the Commissioner of Social Services, the Erie County Comptroller, and the Director of the Division of Budget and Management.
