SUMMARY

The New York State Attorney General's Office wishes to award Erie County \$2,000,000 from a recent settlement, to be specifically be used to allow the Division of Consumer Protection (DCP) to expand it's work and assist in future investigations and legal actions.

FISCAL IMPLICATIONS

There are no fiscal implications on the operating budget. All services will be fully funded through the funding. No match is required, and no County share is anticipated. Pursuant to New York State General Business Law § 774, moneys collected through enforcement actions shall be retained by the County. Two positions would be created to handle the new work, as recommended by the Attorney General's Office:

Position: Deputy Commissioner of Public Advocacy

Annualized Salary: \$63,650

Salary for Balance of Year: \$53,042

Funding Source: 100% State Share

Position: Assistant County Attorney VI

Annualized Salary: \$94,318

Salary for Balance of Year: \$78,598

Funding Source: 100% State Share

Year one of the grant would utilize \$245,021 of the \$2,000,000 award. Between the state award and future ongoing recoveries, this grant program could operate for many years to come.

REASONS FOR RECOMMENDATION

The Buffalo Division of the New York State Attorney General's Office has received a \$2,000,000 settlement from a local debt collection agency and has made said funds available to

the Erie County Office of Public Advocacy Division of Consumer Protection to expand its consumer protection efforts on behalf of Erie County residents.

The grant will allow DCP to expand its programs and to increase its focus on addressing violations by business owners of consumer protection laws such as Article 36-a of the New York State General Business Law §§ 771-776.

The DCP will use the funding to create an Assistant County Attorney position that will be dedicated to enforcing home improvement contract violations set forth in Article 36-a committed by home improvement contractors in their contractual dealings with County homeowners. Enforcing the contract violations has the potential to generate revenue for the County since NYS General Business Law § 774 allows the County to retain any funds it collects as a result of its enforcement efforts. The DCP will also create a Deputy Commissioner of Public Advocacy position to oversee and facilitate the activities of DCP.

Assistant County Attorney VI

Duties required of the position required by Law or Contract:

Enforce and bring action for violation of home improvement contracts.

Position Classification:

MC JG-17

Deputy Commissioner of Public Advocacy

Duties required of the position required by Law or Contract:

Oversee and facilitate an expansion of DCP consumer protection actions as well as provide managerial support to Weights and Measures.

Position Classification:

MC JG-13

CONSEQUENCES OF NEGATIVE ACTION

Failure to approve this resolution will serve to hinder the ability of the DCP to expand its service and provide further assistance to Erie County residents.

STEPS FOLLOWING APPROVAL

The Erie County Office of Public Advocacy Division of Consumer Protection will work with the County Attorney, the Division of Budget and Management, and the New York State Attorney General's Office to accept the settlement funding to set up the grant.
