SUMMARY

The Village of Lancaster is under an Order of Consent from the New York State Department of Environmental Conservation (NYSDEC) to decrease the storm water infiltration into their sanitary sewer system. Aurora St., in the Village, falls within this consent order. The County of Erie maintains, and is responsible for, Aurora St. within the Village limits, from the Village line to Como Park Blvd., including the storm sewer system. The County's storm sewer discharged into the Village's sanitary sewer at several locations. As a betterment to the Village's contract, the County's storm sewers were disconnected from the sanitary sewer system and connections were re-established to the storm sewer.

FISCAL IMPLICATIONS

Funding for this betterment is available in the Transfer Tax (Comm. 9E-18 (2017)) portion of Capital Project B.17050.2.9 – 2017 Capital Overlay, Fund 420, Funds Center 123, in the amount of \$37,875.

REASONS FOR RECOMMENDATION

The Village of Lancaster is under a mandate from NYSDEC to eliminate storm sewer connections to their sanitary sewer. The Village has construction contracts to remove and repair storm sewer connections into their sanitary system. It is to the County's advantage to ask for a betterment in the Village's contract to remove the drainage connections from Erie County Road # 243, Aurora St. from the Village's sanitary sewer.

BACKGROUND INFORMATION

After exploratory testing of the sanitary sewers on Aurora St., there were two storm sewer locations contributing to the sanitary sewer issue. These locations are at the intersection of Lancaster Ave. and Aurora St. and Briarwood Dr. and Aurora St. Work at these intersections entailed replacing storm sewer pipe and catch basins, totaling 144 lineal feet of pipe replacement and 3 new catch basins. The Department of Public Works is asking for authorization on behalf of the County Executive to enter into an agreement with the Village of Lancaster to release the funds necessary to pay for these repairs within the Village's construction project.

CONSEQUENCES OF NEGATIVE ACTION

The Village would not be reimbursed for the funds necessary to remove the County's points of storm water discharge into their sanitary sewer.

STEPS FOLLOWING APPROVAL

The County executive will authorize and sign the Inter-municipal agreement. The County will transfer the funds to the Village of Lancaster in the amount of \$37,385.

COMPTROLLER'S OFFICE REVIEW

The proposed legislation has been reviewed by the Office of the Comptroller and is related to an authorized capital project for which there are sufficient appropriations for the action proposed.

WHEREAS, the Village of Lancaster ("Village") has construction projects for corrective actions eliminating the discharge of storm water into their sanitary sewer system; and

WHEREAS, the County of Erie maintains and is responsible for that portion of Aurora St. within the Village from the Village line to Como Park Blvd., including storm sewers; and

WHEREAS, the Department of Public Works requests authorization for the County Executive to enter into an inter-municipal agreement to reimburse the Village for remediating those locations on Aurora St. as a part of their project.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is authorized to enter into an inter-municipal agreement between the County of Erie and the Village of Lancaster, to reimburse the Village for the cost of the work at the two locations defined on Aurora St.; and be it further

RESOLVED, that authorization is hereby given, for funds totaling \$37,875, available in the Transfer Tax (Comm. 9E-18 (2017)) portion of Capital Project B.17050.2.9 – 2017 Capital Overlay, Fund 420, Funds Center 123, to be disbursed to the Village of Lancaster having completed said work; and be it further

RESOLVED, the Clerk of the Legislature is directed to send five (5) certified copies of this resolution to the Department of Public Works, Commissioner's Office and one certified copy each to the Office of the County Executive, the Division of Budget and Management, the Office of the Comptroller, and the County Attorney.
