### SUMMARY

The Erie County Legislature is requested to receive and file this communication pertaining to the Department of Environment and Planning's issuance of a work order with Ramboll Americas Engineering Solutions, Inc. (Ramboll), for Erie County Sewer District (ECSD) No. 3 in an amount not to exceed \$44,500.00.

### **FISCAL IMPLICATIONS**

There will be no impact to the County's General Fund. The cost of the engineering work related to this communication will be paid from the Erie County Sewer District No. 3 Professional Services Account No. 516020.

### REASONS FOR RECOMMENDATION

The Division of Sewerage Management has issued a work order to Ramboll to assist with the preparation of various reports for the Southtowns Advanced Wastewater Treatment Facility (AWTF) Sewage Sludge Incinerators.

# **BACKGROUND INFORMATION**

On December 16, 2021, the Erie County Legislature passed a resolution authorizing a 3-year Term Agreement with Ramboll for engineering services associated with air permit assistance for ECSD No. 3. At the time of the contract award, the Division of Sewerage Management committed to notifying the Honorable Legislature of each work order issued.

The Term Agreement was approved to provide the Division of Sewerage Management with engineering services required to comply with 40CFR Part 503 Subpart O and 40CFR Part 60 Subpart MMMM. Under this Work Order, Ramboll will provide review for the semi-annual deviation reports, review for the Subpart O semi-annual reports, prepare the annual sludge report, assist in the completion of Subpart MMMM annual compliance report, prepare the annual emission statement, review the source emissions testing protocol and report, assist during the emission testing program, review the test reports of cylinder gas audits, provide operator training, review the mercury module test reports, and provide general air permit regulatory assistance with matters pertaining to the NYSDEC and USEPA.
