RE: Support for Using Plastic Bags at

Grocery and Related Stores Due to COVID-19 Outbreak (INTRO. 9-2)

A RESOLUTION TO BE SUBMITTED BY LEGISLATOR BASKIN, MEYERS, HARDWICK, JOHNSON, GILMOUR, CHIMERA & VINAL

WHEREAS, in 2019, for environmental reasons, the New York State Legislature adopted legislation instituting a ban on the use of single-use plastic bags in stores, grocery stores, drug stores and other establishments, effective March 1, 2020; and

WHEREAS, with the advent of the COVID-19 outbreak, there are concerns about transmission of the virus at grocery and food stores, including potentially through reusable canvass or cloth or other bags owned and used by individuals; and

WHEREAS, while there is no evidence that Coronavirus can be transmitted through such bags, due to the virulence of the virus, there are reasons to be cautious for the time being about any known or potential ways in which COVID-19 can be transmitted; and

WHEREAS, the largest area of possible vulnerability and risk are grocery store employees, such as the cashier, who has to repeatedly touch individual customers' reusable bags; and

WHEREAS, the States of Massachusetts and New Hampshire and City of San Francisco, for instance, have temporarily banned reusable bags during the pandemic, due to these concerns; and

WHEREAS, Tops Markets has temporarily resumed distributing and offering plastic bags for customers due to COVID-19; and

WHEREAS, New York State has also delayed enforcement of the new plastic bag law until May 15, 2020 due to COVID-19.

NOW, THEREFORE, BE IT

RESOLVED, out of an over-abundance of caution, and to support public health and to help stop the spread of COVID-19, the Erie County Legislature expresses our support for any grocery or drug store that desires to temporarily resume using plastic bags during the COVID-19 emergency, to help protect store employees handling customers' reusable bags as well as the customers; and be it further

RESOLVED, that this Honorable Body expresses its support for New York State's decision to suspend enforcement of the plastic bag ban law until the COVID-19 crisis ends; and be it further

RESOLVED, that certified copies of this resolution be transmitted to the Governor, the Commissioner of the New York State Department of Environmental Conservation, the County Executive, and the Commissioner of the Erie County Department of Environment and Planning.

MR. MEYERS moved to amend the resolution by including Et Al Sponsorship. MR. LORIGO seconded.

RE: Expressing Concern Over

Nursing Homes and NYS Dept. of Health Lack of Transparency During COVID-19 Outbreak

(INTRO. 9-3)

A RESOLUTION TO BE SUBMITTED BY LEGISLATOR CHIMERA

WHEREAS, the COVID-19 crisis has revealed stark and troubling issues with nursing homes in New York state, as well as the New York State Department of Health's regulation and oversight of such nursing homes; and

WHEREAS, on April 7, 2020, the Buffalo News reported that "more than 700 of New York State's estimated 100,000 nursing home residents have died from COVID-19, but the state (Department of Health) refuses to identify the nursing homes that housed more than 3,000 residents who tested positive for the highly contagious virus"; and

WHEREAS, when the Buffalo News sought the names of the nursing homes and COVID-19 cases in them, the New York State Department of Health declined to provide any details, but stated that the State Health Department began requiring nursing homes to notify residents and their families about any suspected or confirmed cases of COVID-19 at their facilities, prompting the newspaper to file a Freedom of Information Law request; and

WHEREAS, for instance, the Catholic Health system, which operates the Father Baker Manor nursing home in Orchard Park, reported as of that date that more than 60 people associated with the nursing home, including 41 residents, had tested positive for COVID-19; and

WHEREAS, an 88 year old man died at Mercy Hospital after contracting COVID-19 at Father Baker Manor; and

WHEREAS, The McGuire Group, which operates five nursing homes locally, told the Buffalo News that state and federal guidelines prohibit it from releasing numbers, with its majority

co-owner stating: "The guidance we are getting from the (New York State) DOH and CDC (US Centers for Disease Control and Prevention) is not to release specific numbers"; and

WHEREAS, the local spokesman for the New York State Department of Health contradicted that statement, saying "To be clear, the department's nursing home guidance does not prohibit facilities from publicly releasing the number of COVID-19 positive cases"; and

WHEREAS, in an example of how nursing homes are not timely telling family members of nursing home patients about COVID-19 cases in their facilities or complying with the new State Health Department reporting requirement, the News reported that a patient at Garden Gate Health Care Facility in Cheektowaga (a McGuire Group facility) contracted COVID-19, and her daughter was not told for two days, and then the daughter only found out when she was inadvertently told by the nursing home's social worker; and

WHEREAS, following the News' reporting, Assemblyman Richard Gottfried, the Chair of the State Assembly's Health Committee and Assemblyman Sean Ryan (whose relative was the positive COVID-19 case at Garden Gate), called on the State Health Department to publicly identify the hundreds of nursing homes where residents or staff have tested positive for COVID-19; and

WHEREAS, an elderly man died at the St. Joseph Campus of Sisters of Charity Hospital from COVID-19, a week after being discharged from the Garden Gate Health Care Facility; and

WHEREAS, a spokeswoman for Garden Gate owner McGuire Group told the Buffalo News that because the man was discharged with no signs of the virus, and was no longer a patient when he was diagnosed or when he died, his case does not trigger a notification to Garden Gate's families; and

WHEREAS, two Weinberg Campus residents have died from COVID; and

WHEREAS, the News reported that in late March 2020, some nurses at the Elderwood nursing home in Amherst were so troubled by "what they feared were inadequate safety measures to prevent the spread of COVID-19 that they sent a letter to Erie County District Attorney John J. Flynn, asking him to investigate the situation", and the District Attorney forwarded the anonymous letter to the State Department of Health; and

WHEREAS, family members of patients in multiple nursing homes have come forward to the Buffalo News to report about positive COVID-19 cases in those facilities and the families' concern and anxiety about their loved ones; and

WHEREAS, by April 10, 2020, the number of nursing home residents killed by COVID-19 in New York state had doubled, rising to 1,439 and the number of positive cases in nursing homes had risen to 4,630, which likely is understated due to lack of tests; and

WHEREAS, while stating that nursing homes can themselves publicly report the names of nursing homes where COVID-19 cases and deaths have occurred, the State Department of Health still refuses to do the same and release the data; and

WHEREAS, no one is asking for individual patient information to be released publicly, but merely for nursing homes and the State Department of Health to publicly report positive COVID-19 cases and fatalities at nursing homes to the public in the interest of safety and transparency for the sake of the families of residents and the public at large who may be considering admitting a family member to a facility.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature calls on the New York State Department of Health to enforce its regulations and orders, and to compel nursing homes to immediately report positive COVID-19 cases to the family members of the individual resident who tests positive, as well as reporting the positive cases and death information (without naming the resident or any HIPPA-protected medical information) at nursing homes to the public and the family members of other residents; and be it further

RESOLVED, that this Honorable Body expresses its support for the Erie County Department of Health working with the New York State Department of Health to help provide data and information-sharing that may allow for greater State enforcement of Section 2812 of the New York Public Health Law governing nursing homes and the protection of seniors; and be it further

RESOLVED, that certified copies of this resolution be transmitted to the Governor, the State Commissioner of Health, the County Executive, the County Commissioners of Senior Services and Health, and the New York State Health Facilities Association.

MR. MEYERS moved to amend the resolution by including Et Al Sponsorship. MR. MILLS seconded.

Passes and COVID-19

A RESOLUTION TO BE SUBMITTED BY CHAIR BASKIN

WHEREAS, responding to the COVID-19 outbreak, the Niagara Frontier Transportation Authority (NFTA) has taken extraordinary measures to try to protect their employees and passengers riding on Metro Bus and Metro Rail, such as suspending the collection of fares and on Metro Bus and Rail during the crisis; and

WHEREAS, we owe the men and women of the NFTA are very deepest thanks and appreciation, like all essential employees working during this pandemic, for continuing to come to work and perform their vital transportation service for our community; and

WHEREAS, despite precautionary measures taken by the NFTA to protect operators and riders alike and to help stop the spread of COVID-19, such as the posting of placards urging only 'essential' rides for passengers, the issuance of masks and gloves to drivers, and asking passengers to board the rear of the bus, there are still signs and concerns about COVID-19-related safety on Metro buses; and

WHEREAS, there are reports and indications that many 'non-essential' passengers are riding buses and making non-essential trips; and

WHEREAS, the Amalgamated Transit Union Local 1342 representing NFTA employees have suggested the creation and issuance of a special "essential" passenger pass to help limit non-essential travel; and

WHEREAS, this Honorable Body urges the NFTA to consider additional measures to limit non-essential persons from engaging in non-essential travel during the COVID-19 state of emergency, and to support stopping the spread.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its support for additional measures to be undertaken by the NFTA to further protect its employees and passengers during the COVID-19 outbreak, such as the creation and distribution of an "Essential Worker Rider" bus pass to limit non-essential riders during the COVID-19 outbreak; and be it further

RESOLVED, that the executive director of the NFTA is requested to report to the Legislature on the additional measures the NFTA will undertake to protect their employees and passengers during the COVID-19 outbreak, such as limiting riders on buses to ensure social distancing, creating and issuing special passes, cleaning buses daily, or multiple times/day, etc.; and be it further;

RESOLVED, that certified copies be transmitted to the Chair of the Board of Commissioners of the NFTA, the Executive Director of the NFTA, the Amalgamated Transit Union Local 1342, and the Commissioner of the Erie County Department of Health.

MR. MEYERS moved to amend the resolution for content, and by including MS. VINAL, MR. MEYERS and MS. CHIMERA as Co-Sponsors. MR. LORIGO seconded.

A RESOLUTION TO BE SUBMITTED BY CHAIR BASKIN

WHEREAS, responding to the COVID-19 outbreak, the Niagara Frontier Transportation Authority (NFTA) has taken extraordinary measures to try to protect their employees and passengers riding on Metro Bus and Metro Rail, such as suspending the collection of fares and on Metro Bus and Rail during the crisis; and

WHEREAS, we owe the men and women of the NFTA our very deepest thanks and appreciation, like all essential employees working during this pandemic, for continuing to come to work and perform their vital transportation service for our community; and

WHEREAS, despite precautionary measures taken by the NFTA to protect operators and riders alike and to help stop the spread of COVID-19, such as creating a 12 foot barrier between drivers and passengers, the posting of placards urging only 'essential' rides for passengers, the issuance of masks and gloves to drivers, and asking passengers to board in the rear of the bus, there are still concerns about COVID-19-related safety on Metro buses; and

WHEREAS, there are reports and indications that many 'non-essential' passengers are riding buses and making non-essential trips; and

WHEREAS, transit authorities across the country, including Milwaukee, Phoenix, and Portland, Oregon, have set a limit of 10 passengers per bus to ensure passengers receive safe travel and practice physical distancing while on public transportation; and

WHEREAS, this Honorable Body urges the NFTA to consider additional measures to limit non-essential persons from engaging in non-essential travel during the COVID-19 state of emergency, and to support stopping the spread.

NOW, THEREFORE, BE IT

RESOLVED, that the Erie County Legislature expresses its support for additional measures to be considered by the NFTA to further protect its employees and passengers during the COVID-19 outbreak, such as limiting the number of passengers per bus to 10 during peak periods on highly-trafficked bus routes, placing signage on every other seat to indicate it should be left empty to increase physical distancing between passengers, and creating frequent bus trips during peak times on high usage bus routes to ensure riders are not significantly delayed by passenger limits; and be it further

RESOLVED, that the executive director of the NFTA is requested to report to the Legislature on the additional measures the NFTA will undertake to protect their employees and passengers during the COVID-19 outbreak, such as limiting riders on buses to ensure social distancing, signage, deploying "chaser buses", and cleaning buses daily, or multiple times/day, etc.; and be it further

RESOLVED, that certified copies be transmitted to the Chair of the Board of Commissioners of the NFTA, the Executive Director of the NFTA, the Amalgamated Transit Union Local 1342, and the Commissioner of the Erie County Department of Health.

RE: Calling for the Establishment of a COVID-19 Drive-Thru Testing Site on the East Side of Buffalo (INTRO. 9-5)

A RESOLUTION TO BE SUBMITTED BY LEGISLATOR BASKIN

WHEREAS, a primary focus of the Erie County Legislature is to work with our partners in the Erie County Department of Health, the Erie County Executive, our healthcare partners, and community and civic organizations across the community to decrease the spread of the COVID-19 virus; and

WHEREAS, due to a nationwide, state and local shortage of tests, the Erie County Department of Health established a stated protocol to only test "essential" workers and certain symptomatic persons for COVID-19, with County officials noting that the positive test counts across the county likely significantly under-represent the true, actual number of positive COVID-19 cases; and

WHEREAS, data provided by the County has shown that the zip codes 14215, 14211, and 14208 on the East Side of Buffalo have been severely impacted with positive cases of COVID-19; and

WHEREAS, on April 13, 2020, 14215 had 117 positive COVID-19 cases, 14211 had 55 positive cases, and 14208 had 46 positive cases; and

WHEREAS, Erie County officials have noted that a large number of persons working in healthcare live in the 14215 and related zip codes on the East Side of Buffalo, and indicating potential causality between high numbers of COVID-19 in these communities and the employment status of residents who work as home healthcare aides, nurses, medical assistants, and support positions in nursing homes and hospitals; and

WHEREAS, the 1199 SEIU healthcare worker union has reported that 785 of their healthcare members live in the 14215 zip code, 440 live in the 14211 zip code, and 230 live in the 14208 zip code on the East Side of Buffalo; and

WHEREAS, there are many residents of these zip codes who work at hospitals, nursing homes, skilled nursing facilities, health clinics, and other places, including in individual homes, as medical aides, janitors, cleaners, maintenance workers, kitchen employees, and security personnel, etc. who could be susceptible to COVID-19 by virtue of their employment and designation as essential employees during this crisis; and

WHEREAS, these zip codes have some of the highest rates of poverty in Erie County -26% in 14215, 38.5% in 14211 and 37.3% in 14208 – and therefore, there is a high likelihood that many of the healthcare workers and their neighbors in these neighborhoods are working poor, with limited access to transportation, living wages, childcare, fresh food markets and primary health care; and

WHEREAS, by way of comparison, on March 18, 2020, the Erie County Department of Health operated a drive-thru COVID-19 testing site for certain persons (including non-essential persons who were referred by their physicians) in Lancaster; and

WHEREAS, on March 25, 2020, the Erie County Department of Health operated a drive-thru COVID-19 testing site for certain persons (including non-essential persons who were referred by their physicians) in Amherst; and

WHEREAS, conducting drive-thru testing for COVID-19 is a national model and a safety issue to minimize potential exposure to healthcare workers and other patients; and

WHEREAS, there have been no drive-thru COVID-19 testing sites established in Buffalo so far and the creation of such a site would be helpful and reassuring to the community; and

WHEREAS, on April 11, 2020, the County announced an expansion of testing eligibility for COVID-19, to no longer require a referral from a primary care physician, and to expand testing to include symptomatic persons who receive dialysis and infusion therapy, hospital and community healthcare workers, hospital and community medical facility employees, and their families, such as those who live on the East Side; and

WHEREAS, due to the employment demographics of the East Side of Buffalo, the large number of COVID-19 cases there (and likelihood the data significantly under-counts the true number of positive COVID-19 cases there), and the need to properly test healthcare employees who are working in nursing homes, assisted living centers, private homes and other settings, the County should hold a drive-thru COVID-19 testing site on the East Side of Buffalo.

NOW, THEREFORE, BE IT

RESOLVED, the Erie County Legislature calls on the Erie County Commissioner of Health to immediately establish a drive-thru COVID-19 testing site in, and establish eligibility for healthcare workers and symptomatic residents of the East Side of Buffalo, particularly those in the

14215, 14211 and 14208 zip codes, and including those persons suffering from acute chronic illnesses such as diabetes and asthma who may be more susceptible to COVID-19; and be it further

RESOLVED, that certified copies of this resolution be transmitted to the County Executive and the Erie County Commissioner of Health.

MR. MEYERS moved to amend the resolution by including MS. CHIMERA, MR. JOHNSON, MR. MEYERS and MS. VINAL as Co-Sponsors. MR. JOHNSON seconded.

(INTRO. 9-6)

A RESOLUTION TO BE SUBMITTED BY LEGISLATOR JOHNSON

WHEREAS, a primary focus of the Erie County Legislature is to work with our partners in the Erie County Department of Health, the Erie County Executive, our healthcare partners, and community and civic organizations to decrease the spread of the COVID-19 virus; and

WHEREAS, due to a nationwide, state and local shortage of tests, County officials have noted that positive test counts reported so far across the county likely significantly under-represent the true, actual number of positive COVID-19 cases in Erie County; and

WHEREAS, many residents of the West Side of Buffalo, including the Lower West Side, are African-American, Latino, and other persons of color from multiple nationalities who immigrated to this country, many of whom have helped make Buffalo better as entrepreneurs and small business owners; and

WHEREAS, many of these communities and persons have historically suffered from a lack of access to primary and preventative healthcare and medicine, or have not been able to afford or gain access to health insurance, and could be particularly vulnerable to COVID-19 or not receiving access to testing or services; and

WHEREAS, during the COVID-19 crisis, it is imperative that these persons, many of whom live in poverty-stricken neighborhoods with housing challenges and in close proximity to one another, receive access to COVID-19 testing and services; and

WHEREAS, there are no COVID-19 testing sites on the West Side, creating risk and a need for the medical community to engage these residents and provide diagnostic and healthcare services for them; and

WHEREAS, conducting drive-thru testing for COVID-19 is a national model and a safety issue to minimize potential exposure to healthcare workers and patients; and

WHEREAS, Legislator April Baskin has introduced a resolution seeking a drive-thru COVID-19 test site on the East Side of Buffalo and this resolution is intended as a companion public health effort, in conjunction with that testing site; and

WHEREAS, there have been no drive-thru COVID-19 testing sites established in Buffalo and the creation of such a site on the Lower West Side would be helpful to the community, and community partners are willing and eager to assist with establishing such a site.

NOW, THEREFORE, BE IT

RESOLVED, the Erie County Legislature calls on the Erie County Commissioner of Health to establish a drive-thru COVID-19 testing site in, and establish eligibility for symptomatic residents of the Lower West Side of Buffalo, particularly those persons suffering from acute chronic illnesses who may be more susceptible to COVID-19; and be it further

RESOLVED, that certified copies of this resolution be transmitted to the County Executive and the Erie County Commissioner of Health.

MR. MEYERS moved to amend the resolution by including MR. MILLS, CHAIR BASKIN, MS. CHIMERA, MR. HARDWICK, MR. MEYERS and MS. VINAL as Co-Sponsors. MR. JOHNSON seconded.

RE: Supporting Action to Crack
Down on Price-Gouging Stores

or Entities Operating in Erie

County During the COVID-19 Crisis (INTRO. 9-7)

A RESOLUTION TO BE SUBMITTED BY LEGISLATOR JOHNSON

WHEREAS, in 2019, the Erie County Legislature approved the Consumer Protection Act of 2019, a local law amending the Erie County Charter to create a new Division of Consumer Protection, and the new position of Director of Consumer Protection in the Erie County Department of Public Advocacy; and

WHEREAS, the intention behind this action was for the County to take a leading role on addressing consumer protection and consumer injustices across the county; and

WHEREAS, during the COVID-19 crisis, some stores, retail establishments and/or other entities may be engaging in price-gouging or anti-consumer, anti-competitive actions, such as marking up the prices of foodstuffs, fresh food, cleaning supplies, disinfectants, etc.; and

Voting in New York State

(INTRO. 9-9)

A RESOLUTION SUBMITTED BY LEGISLATORS JOHNSON, MEYERS, CHIMERA, GILMOUR, HARDWICK, BASKIN AND VINAL

WHEREAS, due to the COVID-19 pandemic, via an executive order, the Governor postponed local, school and special elections set to be held in April and May 2020 and moved the special elections to June 23 2020, the current scheduled primary day for New York; and

WHEREAS, after that action, election commissioners from across New York state and the New York State Election Commissioners Association asked the New York State Board of Elections and the New York State Legislature to authorize the expanded use of absentee ballots for the June 23rd election, to protect the public and elections staff alike, and to address concerns that there may not be enough election inspectors, elections staff, or polling places available on June 23, 2020; and

WHEREAS, the Erie County Commissioners of Election have taken steps to facilitate expanded use of absentee ballots for the June 23rd elections due to COVID-19; and

WHEREAS, the recent election on April 7, 2020 in Wisconsin featuring long lines of voters waiting in line for hours to vote (in poor weather) demonstrates the need for action; and

WHEREAS, on April 8, 2020, due to COVID-19, the Governor announced he is issuing an executive order allowing New York voters to vote via absentee ballot for the June 23, 2020 primary and other elections that date, stating "New Yorkers shouldn't have to choose between their health and their civic duty," and noting that he made the decision after seeing long lines forming at polling places for other states' primaries, saying in-person voting poses too great a public health risk; and

WHEREAS, under current state law, absentee ballot requests may only be fulfilled for voters who will be outside of the county in which they are registered on Election Day, are unable to appear at the polls due to illness or disability, or are detained and awaiting Grand Jury action or in prison for a conviction for a non-felony offense, and for instance, individuals with work or family commitments, including people who work multiple jobs or who provide fulltime care for relatives, are effectively barred from casting a ballot on Election Day; and

WHEREAS, under existing state law, voting via absentee ballots is very limited, and voting by mail provisions that are permitted in some states would require a constitutional amendment in New York; and

WHEREAS, in January 2019, the New York State Legislature approved legislation for a proposed constitutional amendment that will allow any voter to request and vote by absentee ballot without needing to declare a reason for doing so, and if a similar measure is approved for a second time in 2021, that absentee ballot voting measure will be on the ballot in New York in the November 2021 election as a public referendum; and

WHEREAS, to enhance voter participation in elections, Common Cause and a county elections commissioner (outside of Erie County) have urged state legislators to codify an absentee ballot expansion into law to allow state residents to vote via absentee ballot for expanded reasons for any future elections; and

WHEREAS, expanded absentee ballot use for any reason helps increase public participation in the electoral process.

NOW, THEREFORE, BE IT

RESOLVED, the Eric County Legislature expresses its support for the expansion of the use of absentee ballots for any reason, to enable and allow New York voters to vote in that manner, and in so doing, to encourage and facilitate maximum participation in the electoral process; and be it further

WHEREAS, data collected from the census is also used to reapportion the boundaries of congressional, state and county legislative lines. It is also used to accurately determine the number of congressional seats each state has in the U.S. House of Representatives; and

WHEREAS, the Census Bureau has extended the deadline for collecting census data from August 15 to October 31, and would reopen some field offices after June 1, which have closed since mid-March due to COVID-19 concerns; and

WHEREAS, on April 13, 2020, the Census Bureau requested that Congress delay the delivery of final census figures to the President by no later than April 30, 2021, and redistricting data to be delivered to the states no later than July 31, 2021; and

WHEREAS, more than 50.5% percent of all American households have currently filled out the 2020 census, while according to the Census Bureau, New York State is lagging behind with only a 44.5% response rate; and

WHEREAS, additional time has been afforded to collect 2020 Census data. It is a finding of this body that additional time need also be given to the Census Bureau to accurately process and disseminate the collected census data.
