Dear Comptroller Mychajliw:

Thank you for expanding the "Taxpayer's Checkbook" section of your website to include expenses that specifically relate to the fund our honorable body established for Covid19. This information is helpful to us as legislators and it provides a level of transparency that taxpayers deserve. There are a number of expenses listed on the most recent report that we believe require further transparency or clarification.

Specifically, we are interested in obtaining further information about Covid19 expenses related to the County's imprest fund, food purchases and contracts with individuals for professional services.

Your report indicates that as of July 10, 2020 \$95,668.84 has been spent from the imprest fund. The Legislature has asked for your office to break down the expenses of the county-wide imprest fund in the past. From those reports we know that imprest funds include a variety of expenditures that might not fit one specific category. Therefore, we think it is important to have a breakdown of those specific expenditures within the Covid19 imprest fund. We are also concerned about the large amount of money spent on purchasing food. We would like to know what was ordered, who ordered it and for what purpose. Lastly, there are several individuals that were offered professional service contracts. With so many county employees at home not working or recently laid off, we would like to see what those contracts entailed.

Thank you for your attention to these questions. We look forward to your response. If you have any questions regarding our request, please contact our legislative staff.

Re: Follow-up on accounting of COVID-19 emergency funding

Director Keating,

Comm. 6E-22 (2020) was submitted to the Erie County Legislature for immediate consideration on March 16, 2020. This legislation was unanimously approved by the Erie County Legislature, and gave your office significantly-expanded authority to deal with unique circumstances that were being presented by the COVID-19 pandemic.

On the initial passage of Comm. 6E-22 (2020), Erie County was in the midst of its first surge in COVID-19 cases, with little known about the disease. In order to address any pressing needs, the Legislature provided the expansion of the County Executive's ability to spend COVID-19 relief funds. The initial resolution called for a report on actions taken to be provided after the emergency ended. This clause read;

Resolved, that because the Legislature is proactively approving of the appropriation of up to \$5 million of 2019 surplus funds to be spent in 2020 without knowing any details, at the conclusion of the coronavirus COVID-19 emergency, the Division of Budget and Management and Department of Health will submit a detailed report to the Legislature detailing all costs associated with the crisis and response (including personnel expense and overtime costs), all vendor payments and new jobs/positions created by the administration to address the coronavirus crisis;

In April 2020, Erie County received an additional \$160 million dollars to assist with COVID-19 related expenses. The vast majority of this money was spent under the same authority authorized in Comm. 6E-22 (2020).

While we understand the COVID-19 pandemic continues and government must still do everything we can to combat it, the spread of the virus has been greatly reduced. Additionally, as a result of increased vaccine rollout, proper social distancing, and community diligence, we are approaching the "home stretch" on our way back to "normal."

Since it has been one year since the creation of the COVID-19 emergency fund, we seek a full accounting of all actions and expenditures taken pursuant to Executive Orders and/or any authority granted under Comm. 6E-22 (2020). The report will help with transparency, and should include the following information pursuant to the amendment passed to Comm. 6E-22 (2020), cited above:

- 1) Every expenditure/action made pursuant to any Executive Order to address the coronavirus crisis;
- 2) Every expenditure made pursuant to the powers granted in Comm. 6E-22 (2020);
  - a. Information regarding personnel costs and overtime expenses;
  - b. All vendor payments made to help address the COVID-19 pandemic;
  - c. All new jobs/positions created to address the COVID-19 pandemic;

Please note, this request is not intended to eliminate the request in Comm. 6E-22 (2020), as amended. That information will still be of interest when the pandemic response has ended and there is no longer a state of emergency.

As you know, Congress has recently passed a new relief bill, which would reportedly send Erie County \$178 million, and we believe it is important that the aid already received and spent is properly reviewed and understood before Erie County embarks on appropriating more.

We appreciate your attention to this matter and look forward to your anticipated response. Sincerely,

## A RESOLUTION TO BE SUBMITTED BY LEGISLATORS, BASKIN, MEYERS, CHIMERA, JOHNSON, GILMOUR, VINAL, BARGNESI, LORIGO, MILLS, TODARO, & GREENE

## Excluding Veteran Disability Compensation from the Income Calculation for an Erie County Senior Citizen Property Tax Exemption

WHEREAS, New York State Real Property Tax Law (RPTL) Section 467 allows local municipalities to offer a senior property tax exemption based on income; and

WHEREAS, state law was amended in 1997 to allow municipalities to "opt out" of including certain income when calculating and providing for said property tax exemptions on seniors; and

WHEREAS, veteran disability compensation is provided by the US Department of Veterans Affairs to former military service members who have a chronic condition that is connected to their service and such payments are intended to compensate them for a decreased quality of life due to their service connected disability; and

WHEREAS, veterans who receive veteran disability compensation are not issued a W-2 or 1099 for such payments; and

WHEREAS, the US Department of Veterans Affairs, Internal Revenue Service, and New York State Department of Taxation and Finance do not consider veteran disability compensation as income;

WHEREAS, under state law, if allowed by local option, property that (1) is owned by persons 65 years of age or older, or by certain other persons whose income does not exceed the maximum established by local option, (2) is used exclusively for residential purposes, and (3) has been owned by at least one of its owners for a minimum of 12 consecutive months prior to application for exemption or for a period of time considered to be the equivalent of 12 consecutive months is partially exempt from general municipal taxes; and

WHEREAS, on July 7, 1970, the Erie County Legislature approved Item 16, a resolution opting into state legislation creating a property tax exemption for Erie County tax purposes for the Senior Citizen Real Property Tax Exemption; and

WHEREAS, that action did not contemplate, nor provide for an exemption or opt-out for those seniors who are veterans who receive disability compensation as defined in Title 38 of the United States Code; and

WHEREAS, the Erie County Department of Real Property Tax Services has identified 356 properties in Erie County that have a disabled veteran exemption (either Alternative or Cold War) and a senior exemption for county tax purposes; and

WHEREAS, these disabled veterans who are senior citizens could lose their senior property tax exemption without action to address this compensation issue and to exclude disabled veteran payments as income when assessors calculate the senior citizen exemption; and

WHEREAS, this resolution is intended to address that issue and to allow for veterans who receive veteran disability compensation to not have that income included in the calculation for an Erie County senior citizen property tax exemption; and

**WHEREAS**, periodically since July 1970, the maximum income level exemption has been reviewed and updated by the Erie County Legislature; and

**WHEREAS**, because the Senior Citizen Real Property Tax Exemption has not been reviewed or revised since 2018, it is necessary to also review and revise the County's exemption threshold based on maximum income eligibility for senior citizens.

#### NOW, THEREFORE, BE IT

**RESOLVED**, that the Erie County Legislature, pursuant to Section 467 of the Real Property Tax Law, as amended, does hereby declare and find that for the purposes of such senior citizen property tax exemption, any such senior citizen who is a service-connected disabled veteran and receives disability compensation from the US Department of Veterans Affairs as defined in Title 38 of the United States Code, shall not have said payments/compensation included in the calculation by any assessor for the purposes of the exemption from the County of Erie real property taxes as initiated and approved by this Honorable Body in Item 16 on July 7, 1970; and be it further

**RESOLVED,** that the Erie County Legislature, pursuant to Section 467 of the Real Property Tax Law, as amended, is interested in participating in the local option to increase the maximum income eligibility for senior citizens to receive a real property tax exemption; and be it further

**RESOLVED,** upon public hearing, the maximum allowable income levels for the Senior Citizen Real Property Tax Exemption for the County property tax purposes are hereby revised to the following levels:

**RESOLVED**, that the Erie County Legislature hereby applies aforesaid exemption schedule to all taxable status dates for the 2022 assessment rolls in Erie County, applying to such tentative assessment rolls prepared on taxable status dates occurring on or after January 1, 2022; and be it further

**RESOLVED**, that a public hearing concerning these partial exemption from taxation and ad valorem levies was held to consider public input; and be it further

**RESOLVED,** that certified copies of this resolution be forwarded to County Executive Mark Poloncarz, Budget Director Robert Keating, Director of Real Property Tax Services Scott Bylewski, County Attorney Michael Siragusa, Acting Senior Services Commissioner Timothy Hogues, Veterans Service Officer Shawn Lavin, and to the Assessors of each city and town in Erie County.

#### SUMMARY

It is recommended that the Legislature authorize the County Executive to enter into a contract amendment with the New York State Office of Indigent Legal Services to extend the contract term for an additional one-year period. In addition, the resolution requests authorization to extend the subcontracts with the Erie County Bar Association's Aid to Indigent Prisoners Society and the Legal Aid Bureau of Buffalo to deliver the services required through the grant.

#### FISCAL IMPLICATIONS

There are no fiscal implications on the operating budget. All services will be fully reimbursed through New York State.

#### REASONS FOR RECOMMENDATION

Legislative approval is required for the County Executive to enter into the contract amendment to extend the grant period and enter into amendments to subcontracts with community agencies.

#### BACKGROUND INFORMATION

Your Honorable Body previously approved COMM 21E-25 (2019) authorizing the County to enter into a three-year contract with the New York State Office of Indigent Legal Services through which \$1,455,129 was made available to Erie County to improve the quality of representation provided to indigent defendants. Erie County utilizes the funds to improve services through the Erie County Bar Association's Aid to Indigent Prisoners Society and the Legal Aid Bureau of Buffalo who contract with Erie County to provide all mandate indigent defense services. At the request of the contract agencies, the New York State Office of Indigent Legal Services has agreed to extend the contract term for an additional one-year period to allow the agencies to complete the terms and conditions of the grant.

#### **CONSEQUENCES OF NEGATIVE ACTION**

Failure to approve this resolution will serve to hinder the improvement of State mandated indigent legal services in Erie County. The contract agencies will be unable to realize full funding under the grant.

#### STEPS FOLLOWING APPROVAL

Grant period will be revised by the Division of Budget and Management. Contract amendments will be executed after final review by the Department of Law as to form.

Re: Sales Tax Revenue Update - November 2021

Dear Honorable Legislators:

Sales tax receipts for 2021 continued to trend in a strongly positive direction through November 2021. As noted in prior 2021 letters from this office and Budget Monitoring Reports from the Division of Budget and Management, sales tax revenue has been significantly above-budget for 2021.

For 2021 year-to-date compared to 2020, the County ended November 2021 \$72.4 million higher in sales tax revenue, or 16.5% higher than the same period in 2020. This is due in part to robust consumer demand and other spending in 2021 as the county and country began the economic recovery after 2020. From a budgetary standpoint, the County ended November 2021 higher by \$91,035,178.94 for 2021 actuals year-to-date compared to the estimated budget, or a positive difference of 21.72%.



- 2. Approval of Board Minutes from June 16, 2021. No comments: motion to approve by Anne Joynt; seconded by Terence Newcomb. Unanimous.
- 3. Approval of Board Executive Session from June 16, 2021. No comments: motion to approve by Terence Newcomb; seconded by Catherine Nagel. Unanimous.
- 4. Administrator Report to the Board:

<u>Communication to the panel</u>: We have continued to issue a weekly Constant Contact each Friday to update the panel on issues of law, process, and local court operations.

<u>Training</u>: We will partner with the National Federation for Justice Communities to develop a series of CLEs in 2022: Cultural Competency:

- 1. Trauma-informed cultural competency;
- 2. Clients from a background of poverty;
- 3. Clients with mental health or substance abuse issues;
- 4. Clients are African-American; NFJC
- 5. Clients who are Somali-American; NFJC
- 6. Clients who are Burmese-American; NFJC
- 7. Clients who are Asian-American; NFJC
- 8. Clients who are Native-American; NFJC
- 9. Clients who are Hispanic-American; NFJC
- 10. Clients in a cycle of domestic violence;
- 11. Clients from the LGBTQA community.

We had an initial conference; this is tee'd up for Tim Franczyk, the Deputy for Training/CLE, to develop further for monthly lunch-time conferences in 2022.

<u>Honors</u> – our Program responded to the request by the Genesee County PD's Office for a nomination for the 2021 Kevin M. Andersen Memorial Award for the annual NYSDA

Chief Defender Convening. Our Criminal Team developed a written and video nomination as to panel member Kelly Kapperman. Another nominee was chosen as this year's recipient.

#### <u>Staff</u>

<u>Diversity</u>: The Program Executive Team has continued to provide an end-of-quarter report with respect to diversity data.

<u>Job Descriptions</u> – the Program Executive Team and clerical supervisors provided me with job descriptions for each of their staff. We are assessing these to develop a workable process for how the Program controls job descriptions.

<u>Remote</u>: we continue to have members of the professional and clerical staff who are working remotely.

<u>Training: New – Screening and Interviewing Candidates for Employment:</u> In the course of having a supervisor and manager conduct the 1<sup>st</sup> round of interviews for the investigator positions, it emerged that there was little experience or training in this regard. We have worked with TripleTrack HR Partners, a women-owned local business, who will conduct a training seminar on Tuesday, September 21. This is the same company that did our annual Sexual Harassment training.

<u>Training: New: Annual Workplace Violence Prevention training</u> - TripleTrack HR Partners is performing this staff training for us on December 7, 2021. This is a new program.

Leadership Training - Prior to my tenure, the Program had invested about \$900 to purchase access to management training through the Disney Leadership Institute. It's a 3-4 hour video presentation that results in a certificate. The persons for whom access was purchased completed this training on July 2. The feedback was not glowing; it was described as "not dynamic....[s]ince Disney is an entertainment powerhouse, I expected to be entertained as well as informed." That it was "geared more towards the multinational corporate world rather than to our world...more appropriate for the entertainment industry and not the legal profession." Going forward, we'll look to spend locally on training resources.

<u>Client Eligibility</u> – Effective June 30, Judge Feroleto rescinded the March 2020 suspension of eligibility screenings; that had mean that all applicants for assigned counsel were deemed eligible regardless of ability to pay for counsel.

#### ILS -

1. <u>Family Court</u> – As previously reported, we applied for the ILS 3-year \$2.5M grant to improve parental representation. This was awarded to Monroe County. This morning we had an opportunity to debrief with ILS' Jami Blair and Angela Burton. They

advised there was a consensus that the Erie County submission was thoughtful; it was easy to read (which meant it tracked the RFP), and it scored very well. Items for consideration next time:

- a. show how the pre-petition work would conform to the ILS standards as to caseload limits;
- b. show how the proposal contemplated pre-petitions referrals other than from DSS/CPS (i.e., from community hotlines or direct requests from people in the community;
- c. more specificity re: community education and outreach; and
- d. more specificity re: training; how technical issues and training would be assessed; how ILS standards would be used to identify issues.
- 2. At a Chief Defenders meeting last week, Director Patricia Warth indicated that ILS would be issuing this week smaller RFPs for upstate counties in the amount of \$160,000. We await the RFP.

<u>Marketing</u> – We met with the Deputy Directors (Dan Grasso and Yvonne Vertlieb) to brainstorm about how to raise the visibility of our program among lawyers and law students. One of the ideas will be discussed in Executive Session.

- 1. UB Law Career Development Office Yvonne will reach out to the law school's CDO to see about promoting through that office.
- 2. BAEC Committees MMP to develop a list of our committees and meeting dates and we will split those up internally to have somebody present at a meeting to promote our program.
- 3. Newly Admitted Attorneys Dan will reach out to the Appellate Division to find out about how to learn about the identity of newly admitted attorneys.
- 4. New Members of the BAEC Dan has the list of new members of the BAEC from the summer edition of the BAEC Bar Bulletin; he will develop a mailing list and draft letter to send to those individuals.
- 5. BAEC Bar Bulletin Article MMP to reach out to the BAEC Marketing Director to see about having articles; we can work from material Tim has already drafted. The Bulletin editor has indicated an interest in publishing a series of such articles.
- 6. Large Firm Retirement MMP to draft a letter that will go out to the big firms re attorneys who are retiring or transitioning out of full-time practice who may be interested in continuing to work on matters for the public good, including for the ACP.
- 7. The next meeting is Tuesday, September 14 at 2 pm; if there's any Board members interested in the topic of how we promote our program please let me know and we'll

include you or feel free to pass along any ideas. POST MEETING EDIT: the next meeting is Wednesday, September 15 at 2 p.m.

<u>Audit</u> – The Auditors have completed their report which will be the subject of a motion in this meeting.

<u>State Legislation</u> – Prior to the adoption of the state budget, we sent letters of support to each of the Erie County members of the state delegation – Assembly and Senate – regarding the bills: 1) to allow appellate review of excessive sentences and suppression ruling regardless of a plea deal; 2) to streamline assignment of appellate counsel by permitting poor-person status to continue on appeal by attorney certification (instead of an onerous defendant application process.

<u>Article 18-B</u> — We alerted our panel attorneys to the lawsuit brought by the Assigned Counsel Association of NYS, et al, against the State and NYC re: the failure to increase the 18-B rate has deprived clients of the effective assistance of counsel. We alerted the leaders of several local bar organizations to ask for their support and advocacy as to the lawsuit:

- BAEC president Hugh Russ will raise it with his Board at the 8/20 meeting.
- John Gaughan, president of the DTLA, forwarded the request to Senators Sean Ryan and Tim Kennedy, to make them aware and to ask them to become ambassadors for this cause. We were copied on Senator Ryan's response, which indicated that he is "a big fan of the Program and was a panel Attorney for many years." We responded to thank him.

<u>Annual Report</u> – I did not locate an Annua Report in our Program records. Once the 2020 Audit is finalized, we will draft an Annual Report to incorporate that information and Progress successes.

### 5. Chief Financial Officers Report to the Board:

Hope Keilman issued an oral report on Program Finances:

- i. June 2021-Under budget by \$600,000 due to lack of 2020 cases.
- ii. June 2021-Cases increased first-half of 2021. We are 20% over compared to 2020.
- iii. June 2021-Vouchers are down 31%. August payment, which is \$650,000, is up around our average monthly attorney voucher payments, it is going back up.
- iv. June 2021-Interpreters have increased, there is a need for refuge and Spanish speaking interpreters.
- v. June 2021-Administrative line expenses are flat compared to 2020.
- vi. June 2021-Unemployment is up 270% due to stimulus.

- vii. June 2021-Voucher Case Management system is up due to currently not charging the fee.
- viii. June 2021-Down on equipment purchases.
- ix. We are good with cash-flow, Erie County paid through September.

#### 6. Unfinished Business:

Report of the By-Law Committee: Michelle Parker explained to the Board that upon its approval, the next step is to go to the Bar Association of Erie County; the change that affects the BAEC is for a 3-year term of the President or their designee in place of the current 1-year term. Hon. John Aman complimented the work of the By-Laws Committee. Motion to approve by Catherine Nagel; seconded by Terence Newcomb; 1 abstention; approved.

#### 7. New Business:

- i. Hon. John Aman requested that all Board members introduce themselves at each meeting.
- ii. Nora Robshaw was introduced to the Board as the new Co-Chair of the BAEC Criminal Committee which she co-chairs with Daniel Grasso; he cannot sit on this Board since he is an employee of Assigned Counsel Program.
- iii. Hugh Russ was welcomed by the Board for his first meeting.
- iv. 2022 Budget: Two-page document was given to the Board. No comments: motion to approve by Terence Newcomb; seconded by Robert Goldstein. Unanimous.
- v. Audit The auditor's Review, Report and 990 Form were sent upon receipt to President Catherine Nagel and Treasurer Ayoka Tucker; also circulated to the Board members with the agenda materials for this meeting. There were no comments. Motion to approve by Ayoka Tucker, seconded by Robert Goldstein. Unanimous.

The real reason is to promote the in-house programs available to support the panel attorneys – social workers, investigators, and in-house attorney support.

<u>Cultural Competency</u>: We are finalizing our contract with National Federation for Justice Communities re: our partnership to develop a series of CLEs in 2022: Cultural Competency. We have brought it to the attention of the Family Court Improvement Project, to the BAEC leadership and DEI Committee, to Legal Aid, and to the 8<sup>th</sup> Judicial District.

#### Staff

<u>Remote</u>: we continue to have members of the professional and clerical staff who are working remotely.

Expansion: We are in the process of moving the Investigation Unit to the neighboring suite, #215. We negotiated for the first month to be rent-free; in November, a wall was knocked down to connect the suite to our main office. We also negotiated for \$2,000 for improvements; we've earmarked this for an expansion to 2<sup>nd</sup> Deputy Yvonne Vertlieb's office.

<u>Diversity</u>: The Program Executive Team has continued to provide an end-of-quarter report with respect to diversity data.

<u>Training: Screening and Interviewing Candidates for Employment</u>: TripleTrack HR Partners, a women-owned local business, conducted a training seminar on Tuesday, September 21 for all supervisors and managers. TripleTrack will also conduct a seminar for all employees on December 7 on Workplace Violence Prevention.

#### ILS -

- i. <u>Family Court</u> As previously reported, ILS selected our Program as one of 5 upstate counties of 24 that applied to receive a 3-year \$500,000 grant to improve parental representation.
  - The plan is to expand our AOD program with an Attorney on Call (AOC) program to provide legal advice to individuals facing CPS investigations at all times of the day or night;
  - the ILS funding would be used to expand the AOD program to include an AOC program wherein attorneys would be on call when Court was

not in session to provide legal advice to clients facing a CPS investigation;

- hire an LSMW for assignment to pre-petition families where appropriate. The LMSW would make immediate contact with the subject family to assess their needs in light of any CPS recommendations. The LMSW's role will be to provide assistance and support to the family, including working through the very challenging issue of housing when necessary. Finally, the LMSW would work with the client and CPS where services are recommended and monitor compliance where an agreement is reached between the client and CPS for pre-petition services.
- Presently, the Department of Social Services (DSS) has agreed to work collaboratively with ACP in pre-petition matters involving educational neglect, children with mental health issues, children living at Compass House (a runaway and homeless youth shelter), and mothers who test positive for a controlled substance or non-prescription drugs. In those types of cases CPS would advise the client that legal advice is available.
- For all other child welfare matters we would rely upon our outreach campaign to get the word out.
- ii. Budget The Year 3 and Year 4 budgets for Erie County have not been finalized by ILS. It's important to note that these budgets contemplate both programs for mandated representation in Erie County: ACP and the Legal Aid Bureau of Buffalo. We are already in Year 4, so it's not ideal for this to still be up in the air. The holdup is Legal Aid; they have construction costs that they are incurring and it's a matter of managing that allocation with ILS. We observed a powerful lesson: while the ILS reps we talk to regularly the ones closer to the ground may indicate an assent to certain spending, it does not mean that is a "yes" when it comes to the ILS Director. A lesson we're relieved to learn from afar. That is why we have not finalized the posting for the position of Deputy for Diversity, Equity and Inclusion.
- iii. <u>Virtual Arraignment Parts</u> The 8<sup>th</sup> Judicial District returned to in-person arraignments by September 13. This was largely due to pressure by ILS. Many of the local village and town justices were fine with virtual appearances and slowing the 8<sup>th</sup> JD's efforts to return to normal operations. ILS considered anything short of in-person contact between defense counsel and the client, and the judge and client, to lend itself to poor quality of representation and poor outcomes. ILS worked with OCA; and our First Deputy Dan Grasso worked with the 8<sup>th</sup> JD to make it clear

that eventually ILS could potentially stop paying for AOD appearances at arraignment. Eventually matters returned to in-person.

<u>Recruitment/Marketing</u> – We have continued to meet with the Recruitment Committee: this now includes Board members John Aman and Terry Newcomb, as well as Deputies Dan Grasso and Yvonne Vertlieb. Since the time of our last report, we met on 9/15, 10/14 and 11/17:

- 1. Yvonne and Dan attended the UB Law Career Fair held remotely on Friday, 10/29 from 1 pm to 5 pm. This went very well. Seven people requested admittance to their "room"; one was an admitted attorney who has now signed on to be a Family Court appellate attorney.
- 2. The barriers: the low-pay, the expense of health care, and the student loan forgiveness available to public interest jobs.
- 3. Yvonne has the ACP listed on the UB Law Career Development Office list of jobs and will continue to monitor and renew.
- 4. Items specific to the Family Court panel
  - a.  $3^{rd}$  quarter -3 people joined
  - b.  $4^{th}$  quarter 2 people have joined in the last ten days
  - c. Yvonne to check with the law school about future attorneys in the joint-degree JD/MSW program.
  - d. Yvonne presented to Family Court clinic run by Judith Olin in the fall semester; thanks to Judge Aman. Looking forward to doing it again in the Spring (Yvonne will reach out for the Spring semester.)
- 5. Items specific to the Criminal Court panel
  - a.  $3^{rd}$  quarter 10 people joined the criminal panel;
  - b. 4<sup>th</sup> quarter on pace for 7 attorneys to join;
  - c. UB Criminal Law clinic Dan to reach out to Deputy CLE Judge Franczyk to see about developing contacts to do a presentation.
  - d. Dan will look into developing law student internship opportunities.

- 6. New admittees Dan obtained info from BAEC about new admittees; will develop an email to reach out to them to see about interest in ACP work.
  - a. Dan to see about getting ACP involved with the Life After Law School presentation to new admittees.
- 7. Bar Association of Erie County
  - a. Bar Bulletin Tim Franczyk put an article in the Bulletin to raise the profile of the program.
  - b. MMP followed-up with BAEC ED Anne Noble to see about being listed every Friday in the Friday missive: we can be listed once a month.
- 8. Next Meeting of the Recruitment Committee: Tuesday, January 11 pm at 12:30 here at our office or via Zoom.

<u>Annual Report</u> – I will draft an Annual Report this month to incorporate the audit information and Progress successes into a report.

- 5. CFO Report Hope Keilman, CFO reported that cash flow is in an excellent position.
  - a. We will be collecting more money from ILS for 1<sup>st</sup>-4<sup>th</sup> quarters, we are waiting for *Hurrell-Harring* budget to be approved.
  - b. We were under budget by \$1 million dollars at the end of September 30, but we just received the bank statement for October, and we will be under budget by \$400,000. We are up 8% in attorney fees over 2020.
  - c. We are under budget in hospitalization costs and over budget on unemployment by 300%, due to rates going up.
  - d. We are currently banking with Citizens Bank; we propose to move to Evans Bank, a local bank, due to convenience for the Program and for the panel attorneys. A switch to Evans Bank will permit us to rely on electronic fund transfer for payment of attorney vouchers, so they will have direct deposit from our program.
  - e. The current accounting system will be saved in cloud and no longer on the server; this change will take place when the banking changes.
- 6. New Business:

- a. Resolution re: banking CFO Hope Keilman advanced a resolution to change the bank to Evans Bank and to identify signatories (the President, the Treasurer, and the Director.) A motion was made by Terence Newcomb; seconded by Hon. Michael E. Hudson; passed; no abstentions; no "nay" votes.
- b. RFP for an Auditor: CFO Hope Keilman issued an RFP to 7 firms; we received 3 responses. One firm does not have the manpower to take on new clientele, the second was Lumsden McCormick and the third was EFPR Group, our current auditor. EFPR Group came in with the lowest bid and CFO Keilman recommended that the Program continue to rely on their services for the audits for 2021 2023. A motion to this effect was made by Terence Newcomb; seconded by Ayoka Tucker; motion passed; unanimous; no abstentions.
