WHEREAS, a new SAP capital project will be created in Funds Center 122, Fund 410, in the amount of the anticipated reimbursement of \$ 300,000 from the UCS.

RESOLVED, that in order to comply with the Unified Court System Eighth Judicial District request to make improvements to the Erie County Court Building, Old Count Hall and the Erie County Family Court Building, a new SAP project (A.18XXX) will be created in the amount of \$ 300,000 for said improvements; and be it further

RESOLVED, that the new SAP project will be created in Funds Center 122, Fund 410, under the supervision of the Department of Public Works – Buildings and Grounds; and be it further

RESOLVED, that the County Executive is authorized to accept reimbursement in an amount not to exceed \$ 300,000 from the UCS after said improvements are made; and be it further

RESOLVED, that the Division of Budget and Management is authorized to make all necessary budgetary and accounting entries to facilitate the acceptance of revenue and outlay of expenditures; and be it further

RESOLVED, that the necessary Project funds are available in the amount of \$375,000 from Fund 420, Funds Center 123, Project B.17076 (2017 5762.22 Warner Hill Road Culvert Replacement Project), and in the amount of \$97,034 from Fund 420, Funds Center 123, Project B.15011 (2015 Preservation of Bridge, Construction); and be it further

RESOLVED, the County Executive is hereby authorized to execute the construction contract with the lowest responsible bidder, enter into a construction phase engineering services agreement with CHA Companies, Inc., and establish a contingency in an amount not to exceed \$472,034; and be it further

WHEREAS, the Erie County Health Lab utilizes instrumentation and equipment which

exceeds the air conditioning system cooling capacity, and the roof top units that serve the laboratory areas are beyond their useful lives, requiring high maintenance and costly repairs; and

WHEREAS, replacement of the various roof top units is required to reduce maintenance costs and allow the laboratory instrumentation and equipment to operate normally while providing optimal occupant comfort year-round; and

WHEREAS, the Erie County Department of Public Works received professional Architectural/Engineering design services proposals for the Erie County Health Lab – 2018 Building 17-AA & BB Roof Top Unit Replacements project (herein called the "Project") on November 6, 2017; and

WHEREAS, LiRo Engineering, Inc. has the necessary expertise and manpower to provide professional design and construction services for the Project; and

WHEREAS, the County Executive is requesting authorization to issue an Agreement to LiRo Engineers, Inc. for providing professional design and construction services for the Project.

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive be authorized to enter into Agreement with LiRo Engineers, Inc. for providing Professional Architectural/Engineering Services for the Project for an amount not to exceed \$70,000, including reimbursables and a design contingency; and be it further
