## 3. COMM. 13E-3 (2006)

## **COUNTY EXECUTIVE**

WHEREAS, the County's four-year plan for fiscal years 2006-2009 calls for a reduction of at least 200 inmates per night at the Erie County Holding Center, and implementing various alternatives to incarceration in order to achieve these reductions; and

WHEREAS, it is expected that such a reduction of inmates will save the County approximately \$1.7 million annually; and

WHEREAS, the County has applied to the Erie County Fiscal Stability Authority for an efficiency grant in the amount of \$685,000 in order to implement alternatives to incarceration; and

WHEREAS, it is expected that the \$685,000 grant, if awarded, will be used towards purchasing electronic monitoring and global positioning equipment (\$387,000), service support from the vendor (\$128,000) and hiring a third-party facilitator to implement the alternatives to incarceration (\$170,000).

NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to accept an efficiency grant from the Erie County Fiscal Stability Authority in the amount of \$685,000, or such lesser amount as may be awarded by the Authority, in order to implement alternatives to incarceration; and be it further

RESOLVED, that in future resolutions, the Legislature will be asked to approve of appropriations of this grant in order to purchase electronic monitoring and global positioning equipment, service support, and hiring a third-party facilitator to implement the alternatives to incarceration; and be it further

RESOLVED, that certified copies of this resolution shall be forwarded to the County Executive, Comptroller, Sheriff Director of Budget, Management & Finance, and the County Attorney. (5-0)

## L. COMM. 13E-4 (2006)

#### **COUNTY EXECUTIVE**

WHEREAS, the County has embarked for the last two years on a strategy which seeks to integrate client delivery of the County's numerous human and social service programs; and

WHEREAS, the key tool for integrating client services is the development of a technology-based case management system whereby clients' enrollment and services would be coordinated across multiple programs; and

WHEREAS, Phase One of the integrated case management system will involve the selfsufficiency programs of temporary assistance, food stamps and employment services; and

WHEREAS, it is expected that Phase One of the integrated case management system will save the County approximately \$1.2 million annually; and

WHEREAS, the County has applied to the Erie County Fiscal Stability Authority for an efficiency grant, known as "Efficiency Grant Proposal Number Two" in the amount of \$1,800,000 in order to implement Phase One of the technology-based integrated case management system; and

WHEREAS, it is expected that the \$1,800,000 grant, if awarded, will be used to implement automated management tools through the County's SAP system.

## NOW, THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to accept an efficiency grant from the Erie County Fiscal Stability Authority in the amount of \$1,800,000, or such lesser amount as may be awarded by the Authority, in order to implement Phase One of the integrated case management system for the County's human and social service programs; and be it further

RESOLVED, that in future resolutions, the Legislature will be asked to approve of appropriations of this grant in order to purchase technology and/or retain consultants to implement Phase One of the integrated case management system; and be it further

RESOLVED, that certified copies of this resolution shall be forwarded to the County Executive, Comptroller, Commissioner of Social Services, Director of Budget, Management & Finance, and the County Attorney.

## 5. COMM. 13E-5 (2006)

# **COUNTY EXECUTIVE**

WHEREAS, it is estimated that the County has excess office space of over one million square feet; and

WHEREAS, preliminary estimates from Public Financial Management (PFM) and the Buffalo Niagara Partnership indicate that the County may save \$3.4 million to \$7 million annually by optimizing its office space; and

WHEREAS, the County has applied to the Erie County Fiscal Stability Authority for an efficiency grant, known as "Efficiency Grant Proposal Number Three", in the amount of \$500,000 in order to hire a professional facilities planning/architectural firm to assist the Department of Public Works in developing a County master plan for space consolidation and relocation.

## NOW. THEREFORE, BE IT

RESOLVED, that the County Executive is hereby authorized to accept an efficiency grant from the Erie County Fiscal Stability Authority in the amount of \$500,000, or such lesser amount as may be awarded by the Authority, in order to develop a County master plan for space consolidation and relocation; and be it further

RESOLVED, that in future a resolution, the Legislature will be asked to approve of appropriations of this grant in order to hire a professional facilities planning/architectural firm to assist the Department of Public Works in developing a County master plan for space consolidation and relocation; and be it further

RESOLVED, that certified copies of this resolution shall be forwarded to the County Executive, Comptroller, Commissioner of Public Works, Director of Budget, Management & Finance, and the County Attorney.
