WHEREAS, Erie County government is mandated to provide a minimum level of government services to residents and taxpayers each day, and

WHEREAS, among the many different types of services are Sheriffs Office road patrols, and

WHEREAS, Sheriff road patrols amount to a basic layer of public safety and protection for motorists, residents and visitors to Erie County, and notwithstanding the presence of policing agencies in particularized communities throughout the county (including, but not limited to, Buffalo, Cheektowaga, Lancaster, Tonawanda and Hamburg), the Sheriffs road patrols are legally empowered to exercise policing functions throughout Erie County, and

WHEREAS, the Sheriff's road patrol arrests or issues summonses to more than 10,000 motorists each year, and the added policing manpower that the road patrol provides to county residents can unquestionably be tied to lives saved, and

WHEREAS, one example of the effectiveness of Erie County's Sheriffs road patrols was evidenced, only a few days ago, and

WHEREAS, on October 2, Deputy Timothy Dusza performed a routine arrest for Driving While Intoxicated (DWI) in the Town of Alden - an action that in and of itself represents a significant service to local motorists -that later turned out to be of even greater significance, and

WHEREAS, upon performance of a computer check of the suspect's record, Deputy Dusza determined that the suspect was the subject of a felony warrant in the State of Pennsylvania for the charge of vehicular homicide; authorities in Pennsylvania subsequently confirmed that they will extradite the suspect for trial within their jurisdiction, and

WHEREAS, this recent example is but one such case where the presence of Sheriffs road patrol in Erie County has resulted in accused suspects being brought to justice to stand trial, and an incidence where lives may well have been saved.

WHEREAS, due to a series of administrative and bureaucratic issues, the NYSDOT has informed the collaborative that the grant application will not be considered for 2005-2006,

WHEREAS, the County of Erie Board of Supervisors created the Erie County Bureau of Forestry on November 15, 1927, and

WHEREAS, in meeting # 40 of said year, it was established that a principal objective to be considered in the maintenance of such lands shall be the sale of forest products, and that those revenues be entered into the general fund, and

WHEREAS, between the years of 1928 – 1938 approximately 7.5 million trees were planted on Erie County Forest lands by the Civilian Conservation Corp. in a plantation style to manage at a later date, and

WHEREAS, in 2003 the County of Erie undertook a formal comprehensive Forest Management Plan of its 3,486 acres of forest land in the towns of Boston, Holland, Concord and Sardinia, and

WHEREAS, during the Forest Management planning process, the highest standards were adhered to governing the principles of proper forest management concentrating on environmental, biological, recreational, economic, educational, and public safety considerations, and

WHEREAS, the Department of Parks, Recreation & Forestry recently sent out an RFP on September 10, 2005 with two respondents conducting a site visit on September 16, 2005, and

WHEREAS, only one firm submitted a formal proposal to the Department of Parks, Recreation and Forestry to prepare and thin approximately 790,000 board feet of timber yielding an estimated \$830,000.00 in sales for 2006, and

WHEREAS, such proposal was submitted by Hillview Logging Inc. of Holland, New York, which proposes to manage forest lots with the assistance of a DEC Consulting Forester, and

WHEREAS, the Parks Department will maintain final approval and control of the Forest Management Program.

NOW, THEREFORE, BE IT

RESOLVED, that the Commissioner of Parks, Recreation and Forestry is authorized to negotiate a contract with Hillview Logging Inc. to manage Erie County Forests, and be it further
