Robert Overhoff Sr. -1789 Crittenden. Questioned again if any new progress from the engineering firm, doing the water study.

Superintendent Sitzman – trying to get all the information ready to present oat the Feb. 9 meeting, waiting to get answers from the ECWA.

Overhoff – sending out water bills Feb. 1, recommend sending letters at the same time. Clerk Wachowiak – they are post cards, but the board can discuss it.

Sitzman – sending out a 2 sided summary of the study to all the water customers. Are anticipating the engineers at the Feb. 9 meeting, but not ECWA. Will know by Monday if it will be on Feb. 9.

Overhoff – who was contacted at ECWA? Sitzman – the engineering firm did the work. Overhoff – comparing price only? Why not quality?

Sitzman – quality is comparable. Comparing rates if county took over, if buying bulk water, if county were to run the current system or take it over completely. Plan on notifying each user.

Overhoff – not everyone gets the Alden Advertiser.

Sitzman – once complete any resident can come to the Village Hall to view the report, waiting for comments from ECWA.

Trustee Daluisio – the study is in the hands of the engineers, so there is no bias. Overhoff – board should be notified of the results and review them ahead of time. How much was the engineering study? Sitzman - \$16,000
