Public Hearing, Community Development Block Grant (CDBG)

Mayor Manicki explained to those in attendance the procedure of the public hearing and the CDBG information. The CDBG is a federally funded program administered by Erie County. Most municipalities are awarded this grant every 2-3 years, but our chances are good again for this year. At this time Mayor Manicki opened the floor for public comment.

Margaret Rose and Robert Harris, 12983 W. Main St. submitted the following: *Sidewalks in good repair for village, walking to parks and downtown, promoting a healthy lifestyle, walkability.

*Development of a connecting bike trail as in Akron. In order to bike safely we must pack up our bikes and drive to Lancaster, Newstead or Clarence. (The Town of Alden had a grant to connect with Lancaster, but did not materialize).

*Verizon FiOS or affordable internet connection. Verizon DSL coming from the Verizon substation in not fast or dependable. (CDBG cannot be used for this purpose)

*Plant more trees. (we have funds budgeted for this)

Superintendent Sitzman suggested Storm Sewers and Sidewalk on Elm St.

Mayor Manicki explained the money is available, but for only for a certain section designated by a recent survey for low income areas. (On Broadway from Alden Village Estates to the Viaduct, south of Broadway to the tracks).

The grant is due to Paul D'Orlando by the end of the month, it is a matching grant. Bob Overhoff asked if it could be used for a dissolution study, but the Mayor said no.

MOTION by Trustee Green and seconded by Trustee Daluisio to exit the Public Hearing and re-enter to the regular meeting. Carried.
