<u>Superintendent Sitzman</u> – heard from the DEC, who is working with the funding agency on the WWTP project. A yellow dot stickers in place in the window of the car signifying information is in the glove compartment. It can also be used in the home signaling information is in the freezer. Kits are available in the Village of Alden Clerk's Office for our residents.

The Alden Fire Department also offers a similar program, file for life, which is placed on the refrigerator.
