MOTION by Trustee Mezydlo, and seconded by Trustee Warmus, to approve the fire/EMS calls for the period of July 11- August 7, 2015. Carried.

MOTION by Trustee Mezydlo, and seconded by Trustee Retzlaff, to accept with regrets, the resignation of Thomas Cantie as the Planning Board member, effective August 19, 2015. Carried.

MOTION by Trustee Mezydlo, and seconded by Trustee Warmus, to grant Alden High School permission to hold the annual Homecoming Parade on Thursday, October 1, 2015. The parade begins at 6:15 pm at the High School and follows the following route: Park to Baxter, Baxter to Irving, Irving to Emerson, and Emerson to Park. They request blocking off these roads, but they must contact for police service. Carried.

On the question: Mayor Manicki explained the changes were recommended by the auditors to update in compliance with GASB.

MOTION by Trustee Mezydlo, and seconded by Trustee Warmus, to approve changes to street addresses of lots at 1306 Duchess Lane and 1354 East Drive in the Alden Village Estates Mobile Home Park, due to errors in the lot layouts when the park expansion was originally constructed. These lots front on Amber court, and street addresses will be assigned accordingly. Carried.

MOTION by Trustee Mezydlo, and seconded by Trustee Retzlaff, to set a public hearing for consideration of a Special Permit for Severyn Development (Birch Creek Run Patio Home Development), 13030 Main Street, at 8:15AM on Thursday, August 27, 2015. Carried.

MOTION by Trustee Retzlaff, and seconded by Trustee Mezydlo, to approve an extension to Alden Village Estates, 13515 Broadway, to provide a final park layout plan for the original section of the Alden Village Estates Mobile Home Park. Plan must be submitted on or before October 7, 2015. Carried.

WHEREAS, Village of Alden has reviewed the Plan and affirms that the Plan will be updated no less than every five years:

NOW THEREFORE, BE IT RESOLVED by Board of Trustees that the Village of Alden adopts the ERIE COOUNTY, NEW YORK, MULTI-JURIDICTIONAL HAZARD MITIGATION PLAN UPDATE as the jurisdiction's Natural Hazard Mitigation Plan, and resolves to execute the actions in the Plan. Carried.

<u>Superintendent Sitzman</u> – Elm St. sewer engineer project will be bid out in Sept, with a fall construction date. Received the wastewater engineering study, and will review to advance to phase 2. Nov. storm damage repairs near completion.

CEO Czechowski –at the work session, reviewed the patio home development slated for W. Main St., ZBA meeting 8/18 and Public Hearing 8/27.

Mayor Manicki – attended a meeting wit Attorney Trapp and 6 other municipalities to address Time Warner concerns of franchise agreements, Buffalo based feed and internet access for everyone, especially in rural areas. Erie County Highway will not be repairing Exchange St. this year. They will patch it this year and possibly address the drainage issues next year, will contact the village after Christmas. They did "repair" the receiver on Crittenden, and have another 50-60 to address. E.C. sales tax up 1.13% from last year at this time. Congratulations to the Alden Historical Society for winning 2 blue ribbons at the Erie County Fair.
