## **BUSINESS FROM FLOOR-**

Several students in attendance asked questions of the board.

Dick Kegler – 1426 Mechanic. August first there were water restrictions placed on taxpayers, but not on the school. Questioned the rates and if sewer was charged. Mayor Manicki – they paid the full rate. Town and school charged full rate on sewer @80 cents/1,000. Residents will go back to the regular rate as of October 16th Recycling? We are currently being charged \$5/ton as we recently went out to bid. We accepted the bid from the same company. We used to get paid for recyclables and now we have to pay. People should donate clothing, and get it out of the garbage cans. Robert Overhoff Sr. –1784 Crittenden Rd. Reading from minutes from over the years. Jan. 14ht, Aug. 11<sup>th</sup>. Rate is now \$3.95? The ECWA rate is \$3.17.

Mayor Manicki - debt doesn't go away.

Overhoff -We have three choices offered by ECWA, buying bulk water is the best option in my opinion. With bulk everything would stay. Will there be a rate increase?

Mayor Manicki- Our rate includes hydrants \$120/hydrant per year. The maintenance of the system is expensive. Yes there will be an increase.

Overhoff - have you had ECWA here at public hearing?

Mayor Manicki – no, no public hearing, bulk mailing all the residents for opinions. It allows people to make the decision, we are not sure how long it will take.

Mr. Reimer – 13437 Broadway. I have health problems and with the sidewalk to Alden Landings Mobile Home Park, it is a problem. Holes in sidewalk  $\frac{1}{2}$  in sidewalk,  $\frac{1}{2}$  in approach. Other holes in approach and driveway.

Superintendent Sitzman will look into it. If we see it is our responsibility, we will take care of it, if not will notify the park owners.

Chuck Airey – 12896 Broadway. Ambulance service, does the additional cost affect the residents? Not in the General Fund, only maybe with your insurance.

## **REPORTS FROM COMMITTEES/DEPARTMENTS:**

<u>Superintendent Sitzman</u> – lifted restrictions from mandatory to voluntary, but please continue to use common sense. If valves work, will fix water valve leak at Crittenden and Broadway, Crack sealing next week.

**Trustee Daluisio** –lighted pedestrian crossings, would like to see this happen. People just don't think they have to stop, village has been doing research looking for funds, not available. Asking the board to find the money\$12,000-\$13,000 for at least two crossings. Have talked to the company and they will come out here to do a study. They are highly visible, estimated 350 crossings per day. A student questioned the proposed locations – Broadway at Church and Broadway at Emerson. Dick Kegler asked about CDBG money

- Will meet up with Superintendent Stoltman of the schools. We don't want to spend, but safely is most important, grant money available to large cities.

<u>Attorney Trapp</u> – have filed Local Laws 1-9 with the state, there is a ZBA hearing on Oct.4, sent GHD contracts to Superintendent Sitzman.

Mayor Manicki – Exchange St., Erie County advised no work this year, will be considered for 2017.
