Carried.

MOTION by Trustee Mezydlo, and seconded by Trustee Retzlaff, to approve the contract with Industrial Appraisals, for \$5,675.00, pending clarification of what they term as replacement values. Carried.

#### **BUSINESS FROM FLOOR:**

Pat Cavanaugh, DPW Laborer, and Safety Committee member reiterated the concern for drug and alcohol testing, addressed at a prior meeting. All the DPW employees are randomly drug and alcohol tested, and he feels it should include all village employees and the crossing guards, who are paid by the Village of Alden. Mayor Manicki, replied the testing is for employees who operate machinery. Cavanaugh, reasoning is that the girls in the front office handle a lot of money, and the crossing guards are responsible for the safety of the children.

Dan Czelusta, Water/SPT Operator, agreed with Cavanaugh concerning the drug and alcohol testing; also felt that all employees should have background checks, not just the DPW hires. Alden Junior Football does checks on all the coaches, the background

checks should be done on everyone including the crossing guards. Czelusta stated that "if something happens the Village is liable"

Mayor Manicki will take this under consideration, and consult with the Attorney, who was not present at the meeting.

### REPORTS FROM COMMITTEES/DEPARTMENTS:

<u>Mayor Manicki</u> –met with the Town Supervisor, school, Fire Dept. and car show committees, who were all pleased with the way the car show went, calling it a worthy event. Looking to repeat it again next year. Thanked the Fire Dept and Fire Police, for the good job they did directing traffic during the car show. Congratulated on a job well done by the DPW on the bandstand and garage roofs.
