Clerk Galbraith – we will be closed Friday in honor of Veteran's Day. Water bills due Nov. 28 **CEO Czechowski** – requesting an executive Session for litigation.

Trustee Casell – what is the annual \$25 charge for the banners? it is to cover the cost of hardware, brackets, poles, end caps, twist ties and the 2-3 days it takes each spring and fall to put them up. In the spring, we had to rent a lift. We also had to purchase boxes to put them in and store them. They are marked, so that they should go up in the same positions as last year. **Mayor Prucnal** – code red postponed for new from town.
