BUSINESS FROM THE FLOOR

Dick Kegler – Mechanic St. – thank you Superintendent and crew for mowing the viaduct, it looks nice. Thank you for cleaning up on the southside of Broadway streetscape. I submitted FOIL paperwork to review past budgets. Money was made available to pave Railroad and 3 other streets in the past: in the general fund \$40,000 was set aside yearly from 2013-2016, in 2016-2017 budget \$10,000, in 2017-2018 - \$120,000 and in 2018-2020 \$40,000 each year. Would like the Trustees to look back and see where the money went. Why are we using our accumulated CHIPS (Consolidated Highway Improvement Program) funds? There have been no street projects in the past 16 years. Superintendent Pruitt – money used for streets, such as cleaning DI's, Oiling the streets before winter, milling Baxter Ave, pouring gutters and such. Kegler – I live on Mechanic and Zoladz trucks have been going up and down Mechanic from 6 am - 7 pm daily, it is not made for this truck traffic, they are supposed to go down Exchange St.,

Mechanic is posted 10 tons.

Kegler – south side of streetscape on Broadway is liftin up around tree roots, especially in from of the Historical Society – it is at lease more than 12" variance. Superintendent – on our list of things to do.

Karen Howard, Senator Gallivan's office was present. The senator is running unopposed and has all of Erie County for his jurisdiction.

Superintendent Pruitt - Phase III of Elm St. in the spring, Phase III WWTP- next week. Parking Ban Nov. 1- April 1.

Attorney Trapp –Waste Management contract for recycling is \$5 till 2024. We recycle 7 tons per week.

Trustee Refermat – meeting with employees, great group of people. Finishing interviews soon. **Trustee Casell** – construction over well – ARPA money? Superintendent – all engineering and design phases completed, purchasing platform over well – pole barn, pour cement, railings - \$40,000.
